

## **Pakistan One Fund**

**Amendment No. 1 to the  
Memorandum of Understanding  
between  
the International Organization for Migration,  
and  
the United Nations Development Programme  
regarding the Operational Aspects of the Pakistan One Fund**

**WHEREAS**, the Memorandum of Understanding (hereinafter referred to as "Memorandum") between the International Organization for Migration (hereinafter "IOM") and the United Nations Development Programme, as Administrative Agent for the Pakistan One Fund, (hereinafter "UNDP") was concluded on 17 June 2008;

**WHEREAS**, the United Nations in Pakistan have now developed a "One Programme II 2013 to 2017", as part of their respective development cooperation with the Government of Pakistan.

**WHEREAS**, the Participating UN Organizations to the Pakistan One Fund have concluded an Amendment No 2 on 20<sup>th</sup> December 2012 to the Memorandum of Understanding relating to the Operational Aspects of the Pakistan One Fund and thereby extended the duration of the Pakistan One Fund until 31 December 2017, based on the development of the "One Programme II 2013-2017", (attached hereto as Annex I),

The Memorandum of Understanding between the International Organization for Migration and the United Nations Development Programme (acting as Administrative Agent for the Pakistan One Fund) is therefore modified as follows:
