

Pakistan One Fund

**Amendment No. 2 to the
Memorandum of Understanding
between
Participating UN Organizations,
the United Nations Resident Coordinator
and
the United Nations Development Programme
regarding the Operational Aspects of the Pakistan One Fund**

WHEREAS, the Government of Pakistan requested the members of the United Nations Country Team, chaired by and under the leadership and coordination of the United Nations Resident Coordinator in Pakistan to develop a single framework for their activities in support of national development priorities in accordance with the Pakistan national priorities and, accordingly, the members of the UNCT prepared the "*Delivering as One: One Programme 2008-2012*" ("One Programme Document"), signed on 9 February 2009, and agreed to establish a coordination mechanism, the "High Level Committee" to facilitate effective and efficient collaboration between the Participating UN Organisations and the host Government for oversight of the Pakistan One Fund, and a High Level Committee Finance Sub-Committee to decide on unearmarked allocations of resources;

WHEREAS, the Participating UN Organizations that have signed the Memorandum of Understanding dated 17 June 2008 and Amendment One on 29 December 2010, have agreed to establish a joint development fund (hereinafter referred to as the "Pakistan One Fund") that, under the leadership of the Resident Coordinator, that facilitates the coordinated resource mobilisation, allocation and disbursement of donor contributed resources for the unfunded elements of the One Programme Document, starting on 1 June 2008 and ending on 31 December 2012.

The Participating UN Organizations have now developed the **One Programme II (2013-2017)**, as part of their respective development cooperation with the Government of Pakistan.

The Memorandum of Understanding between the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme (acting as Administrative Agent of the Pakistan One Fund) is therefore modified as follows:

Preamble:

WHEREAS, the Government of Pakistan requested the members of the United Nations Country Team, chaired by and under the leadership and coordination of the United Nations Resident Coordinator in Pakistan to develop a single framework for their activities in support of national development priorities in accordance with the Pakistan national priorities and, accordingly, the members of the UNCT have now prepared the "**Delivering as One: One Programme II 20013-2017**" ("**One Programme II Document**"), starting on 1 January 2013 and ending on 31 December 2017;

WHEREAS, the Participating UN Organizations that have signed the Memorandum of Understanding dated 17 June 2008 and Amendment One on 29 December 2010, have agreed to establish a joint development fund (hereinafter referred to as the "Pakistan One Fund"),

which has now been amended to start on 1 January 2013 and end on 31 December 2017, as may be amended from time to time, that under the leadership of the Resident Coordinator, facilitates the coordinated resource mobilisation, allocation and disbursement of donor contributed resources for the unfunded elements of the One Programme II Document 2013-2017, as more fully described in the revised Terms of Reference of the Pakistan One Fund 2013-2017 dated 06 December 2012, (hereinafter referred to as the "TOR"), a copy of which is attached hereto as ANNEX A.

All subsequent references to the "the High Level Committee Finance Sub-Committee" in the Memorandum of Understanding Sections I - XI are hereby amended to " Oversight Committee", while all references to the "Joint Programme Steering Committees" and "Joint Programme Task Forces" are amended in line with Governance Arrangements in the revised Terms of Reference of the Pakistan One Fund 2013-2017. Annex A is replaced by the Terms of Reference of the Pakistan One Fund 2013-2017.

All other terms and conditions of the Memorandum of Understanding remain unchanged.
