## Reason Revision is being requested

One of the key activities was to hire a protection mainstreaming trainer for the Cluster to be based in Somalia. The recruitment took a long time due to the fact that it was difficult to find a trainer with the requisite experience who also would be comfortable to live and work in Mogadishu, as the position is based full-time in that city. Finally, while the right person was found, he was not immediately available without the requisite HEIST or SSAFE training he cannot be based permanently in Mogadishu. The trainer arrived in early December, went to Mogadishu under a waiver for one week, will complete the HEIST in early January, and begin actual training by end of January 2013.
