

## CAPE VERDE TRANSITION FUND

**Amendment No. 1**  
**Memorandum of Understanding**  
**between**  
**the International Organization for Migration (IOM),**  
**the United Nations Resident Coordinator**  
**and**  
**United Nations Development Programme**  
**regarding the Operational Aspects of the Cape Verde Transition Fund**

**This Memorandum of Understanding** (hereinafter referred to as “MOU”) is concluded between the International Organization for Migration (hereinafter “IOM”), an inter-governmental organization, established by treaty and having its headquarters at 17, Route des Morillons CH-1211 Geneva 19, Switzerland, the United Nations Resident Coordinator in Cape Verde (hereinafter “Resident Coordinator”) and the United Nations Development Programme, a subsidiary organ of the United Nations, having its Headquarters at One United Nations Plaza, New York, New York 10017, USA, as Administrative Agent of the Cape Verde Transition Fund, (hereinafter “UNDP”);

**WHEREAS**, the Participating UN Organizations to the Cape Verde Transition Fund have signed a Memorandum of Understanding Amendment No 2 relating to the Operational Aspects of the Cape Verde Transition Fund (attached Annex A hereto);

**WHEREAS**, IOM wishes to participate in the Cape Verde Transition Fund and receive funds on the same terms as the Participating UN Organizations;

**WHEREAS**, the Participating UN Organizations and Donors to Cape Verde Transition Fund agree to IOM’s participation in the Cape Verde Transition Fund;

**WHEREAS**, the Participating UN Organizations authorize the UN Resident Coordinator and UNDP, represented by its Multi-Partner Trust Fund Office, as Administrative Agent to conclude this Memorandum with IOM for its participation in the Cape Verde Transition Fund;

**NOW, THEREFORE, The One UN Steering Committee and the UNCT have agreed to extend the duration of the programmes supported under the Transition Fund until 31 December 2016.**

Accordingly, the Memorandum of Understanding between IOM, the Resident Coordinator and the UNDP, represented by its Multi-Partner Trust Fund Office acting as Administrative Agent of the “Transition Fund”, is therefore modified as follows:

**WHEREAS**, the Participating UN Organizations to the Cape Verde Transition Fund have signed a Memorandum of Understanding Amendment No 2 relating to the Operational Aspects of the Cape Verde Transition Fund (attached Annex A hereto);

*All other terms and conditions of the Memorandum of Understanding remain unchanged.*
