

**Amendment No. 1 to the  
Memorandum of Understanding  
between  
the International Organisation for Migration,  
and  
the United Nations Development Programme  
regarding the Operational Aspects of the Sierra Leone Multi-Donor Trust Fund**

**WHEREAS**, the Memorandum of Understanding (hereinafter referred to as "Memorandum") between the International Organisation for Migration (hereinafter "IOM") and the United Nations Development Programme, as Administrative Agent for the Sierra Leone Multi-Donor Trust Fund, (hereinafter "UNDP") was concluded on 21 October 2009;

**WHEREAS**, the Participating UN Organizations have concluded an Amendment No 1 to the Memorandum of Understanding relating to the Operational Aspects of the SL-Multi-Donor Trust Fund on 25 February 2013 (attached hereto as Annex I) and thereby extended the duration of the Sierra Leone Multi-Donor Trust Fund until 30 June 2013, in order to allow projects supporting the Joint Vision for Sierra Leone to complete implementation of their activities and reporting obligations,

The Memorandum of Understanding between the International Organisation for Migration and the United Nations Development Programme (acting as Administrative Agent for the Sierra Leone Multi-Partner Trust Fund) is therefore modified as follows:

**Agreement:**

3. IOM agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding and its Amendment No 1 entered into between the Participating UN Organizations and the UNDP MPTF Office attached hereto as Annex I, which is an integral part of this MOU.

*All other terms and conditions of the Memorandum of Understanding remain unchanged.*
