3. BACKGROUND AND NEEDS ANALYSIS (please adjust row size as needed)

(A) Describe the project rationale based on identified issues, describe the humanitarian situation in the area, and list groups consulted. (maximum 1500 characters) *	According to the 2012 Post Deyr FSNAU report, the national prevalence of Global Acute Malnutrition is estimated at 14.3 %, reflecting a stabilization of the nutrition situation over the past year. South Central Somalia hosts 74.4% of the country's total estimated caseload. HMIS data and rapid nutrition assessment's results indicate that the situation remains "Very Critical" in Gedo, Juba, and north Bakool areas. In Puntland, the nutrition situation remains "Critical"; IDPs in Garowe and Galkayo are "Very Critical"; while IDPs in Qardho and Bossaso are "Critical". In the central region the overall nutrition situation has also improved since Deyr 2011-12 except in Hiran pastoral areas and IDP settlements in Guriel, which are classified as "Very Critical". In close coordination with the Nutrition Cluster and within the framework of the IMAM service plan jointly developed with UNICEF, WFP plans to pursue the provision of nutrition treatment services for moderately malnourished under five year old and malnourished PLW in the aforementioned regions. The long term trend analysis of the nutrition situation has revealed the seasonal variability of the nutrition among pastoral and IDP communities. In the livelihoods where seasonal variations in GAM prevalence are reported, seasonal BSFP focusing on under three years old in IDP settlements and vulnerable rural communities will be implemented to prevent further deterioration of nutrition status.

(maximum 1500 characters) *	WFP operates in Puntland and South Central Somalia through an expanded network of local and international NGOs. TSFP is targeting malnourished U5 and PLW while BSFP focuses on at risk U3s in vulnerable communities. In the project area 153,000 children under five years old are expected to be malnourished. With the exception Bossaso IDPs, statistical analysis of Deyr 2012 survey findings show no statistically significant differences between acute malnutrition with sex of the child. Considering the current coverage of WFP supported TSFP services and needs in Southern Somalia, WFP plans to rehabilitate 15,000 moderately malnourished children and PLW in 12 districts over the project duration, requiring 125.78 MT of Plumpy Sup. Amongst IDPs and in area of high nutrition vulnerability, the delivery of MAM treatment services to U5 and PLW will be complemented during the lean season with the implementation of BSFP targeting U3 only. WFP anticipates that BSFP will be most likely needed in IDPs settlements, coastal districts of Puntland and Central zone, and among pastoral communities of Hiran, Gedo, Lower Juba and Bakool regions. The decision to trigger seasonal BSFP will be based on a quarterly review of early warning indicators at livelihood level. The current funding will allow WFP to target 41,800 children less than 3 years over the project duration, requiring 200 MT of Plumpy Doz.
(C) List and describe the activities that your organization is currently implementing to address these needs.(maximum 1500 characters)	TSFP and BSFP are already implemented in all the project areas. The current funding is meant to ensure the continuation of services and sustain the availability of MAM treatment and preventive services for communities at risk. This is essential to ensure gains made with the famine response are not lost due to the lack of resources. Over the past year, complementary activities have been incorporated in WFP nutrition interventions in line with the Basic Nutrition Service Package (BNSP): micronutrient supplementation, provision of essential drugs, comprehensive nutrition counseling and education, support to Community Nutrition Workers for active case finding and referral. In conjunction with the provision of nutrition services, WFP supports a large range of livelihoods interventions (food-for-asset creation, food for training) to better address underlying causes of acute malnutrition at community and household level. Implementation of nutrition services are aligned with the pillar 2 of the Resilience Strategy, increasing access to basic social services.
