Wider Meeting for "TOR Sharing and Formal Establishment of Civil Society Alliance on Nutrition"

A wider meeting was held to share drafted term of reference (ToR) and formal establishment of Civil Society Alliance on Nutrition in Nepal (CSANN) on 20 February, 2014 at Hotel



Summit, Lalitpur. The meeting was organized by Interim Committee, formed from consultative meeting held on 26 January 2014, with support from Save the Children. It was chaired by Ptof. Dr. Uma Koirala – coordinator, Interim Committee, The meeting was facilitated by Mr. Atma Ram Pandey, Ex-Secretary of GoN and attended by the representatives of different civil society organizations, networks and academia.

The programme was started with the welcome speech of Dr. Uma Koirala. She welcomed all and also highlighted on the objectives of the meeting. Ms. Neera Sharma, Sr. Programme Coordinator of Save the Children shared about the relevancy of CSO Alliance on Nutrition (Save the Children is the main implementing partner of CSANN and has been supporting the Participant sharing idea in the CSANN from its conception). Dr. Ojaswi Acharya, Interim Committee member presented the term of reference (ToR of CSANN) drafted by the Interim Committee on 17-18 Feb. 2014. After the presentation, the floor was opened for the discussion.

Issues Raise:

 The participants expressed their concern whether the alliance will work completely being adhered to the SUN movement or it will operate as an independent body. – The ToR clearly mentioned that alliance will work beyond SUN movement. Mr. Sumit Karna, Nu-Tech emphasized on need to include Conflict of Interest

management and activities alliance sustainability. He to include private sectors activists expertise. also came that CSANN on implementation of legal nutrition which are not



focusing on also highlighted and other Suggestion was should advocate acts on yet

implemented, and monitor the Multi Sectoral Nutritional Plan activities in the piloting districts.
