<b>Project Summary :</b>	<p>The project seeks to ensure the provision of protection support to individuals at high risk: those belonging to minority groups whose freedom of movement has been significantly limited as a result of the conflict, victims of child labor and sexual exploitation, women and girls at risk of gender based violence (GBV), and other vulnerable groups.</p> <p>In rural areas outside of Yaloke and Bouar, ethnic and religious minorities remain at risk of being killed or held against their will by members of illegal armed groups. In areas that are currently inaccessible to humanitarian agencies, local protection committees and other sources indicate that children are used as labor in mines and women and girls are sexually exploited. Moreover, community and state protection mechanisms have been severely disrupted by the conflict.</p> <p>Building on Mercy Corps Protection programming in Bouar, Baboua, and Yaloke, this project will expand protection coverage on the “axes” between Bouar-Niem, Bouar-Bozoum, Yaloke-Bossemele, Yaloke-Zawa-Gaga, Yaloke-Gadzi. Mercy Corps will establish mobile listening centers to carry out protection and livelihoods activities, while existing listening centers in Bouar and Yaloke will serve as points for referencing the most severe cases of GBV/Human rights abuses. Twenty-five newly established protection committees will work in the monitoring of protection incidents. These committees will be trained in the identification and case referral of GBV and Human Rights abuses. Dignity kits and NFI kits will be distributed to the most vulnerable survivors, as cash transfers are considered to be more problematic based on our Do No Harm analysis, which concludes that cash transfers in this context may put beneficiaries at risk. A number of these survivors will receive Income Generating Activity (IGA) training and business start-up kits.</p> <p>Working towards sustainable solutions for community stabilization, youth at risk of enrollment in armed groups or forced labor will also receive vocational training. Likewise, recreational activities and group discussions will be implemented in the five project locations. These communities need to re-establish relationships through peaceful dialogue in order to air grievances and resolve differences.</p>

Monitoring missions with Protection Monitors and Community Mobilizers will serve to inform locals in villages of the Protection mechanisms being implemented. Monitoring missions will also feed into larger response mechanisms such as the Protection Cluster.

Awareness raising sessions will reach those who are not directly benefitting from Protection care.

While Listening Centers principally benefit survivors of GBV, cases of non GBV needing psychosocial support will be welcome.

**Catchment Population:**

Radio messaging on protection themes will reach the catchment population, informing them about the referral system and community networks put in place to respond to GBV and human rights abuses.

Community networks, formed and trained during the project, will be able to continue to refer cases of GBV and Human Rights abuses to the Listening Centers or medical service after the project.

**Link with allocation strategy :**

Through the provision of emergency assistance to persons affected by conflict in the Center North-West and through community dialogue initiatives in the areas with substantial presence of illegal armed groups, the project responds to the fund's strategic objective (life-saving response):

1. Soutenir la provision d'assistance humanitaire pour répondre à des besoins critiques nouveaux (« life saving ») afin d'assister les personnes vulnérables nouvellement déplacées et retournées et les populations à risque à la suite d'un choc ou d'une crise.

The objectives for the proposed project are the following :

1. Strengthen the data collection of protection incidents and create an early warning and response mechanism.
2. Meet the immediate needs of those in need of protection through access to holistic and timely response and support services.
3. Contribute to community stabilization through the provision of livelihoods and conflict mitigation activities.

The project responds to the Protection Cluster Strategic Priorities as follows:

1. Développement d'un mécanisme/capacité de réponse rapide multisectoriel aux nouveaux besoins de protection

Through the development of data collection systems and holistic case management (rapid provision of medical, economic, legal, and psychosocial support) the project aims to respond to the first Protection Cluster strategic priority for the allocation.

2 Renforcement du mécanisme d'alerte, de monitoring protection et de référencement des cas individuels

The existing Mercy Corps protection monitoring system will be integrated and reinforced under the current project. This will increase the visibility and coverage at village level of the monitoring system in the targeted 4 sub-prefectures, thereby responding to the second Protection Cluster strategic priority.

3 Mise en place de mécanisme de protection et de dialogue communautaire selon l'analyse des risques

The project will include community dialogue initiatives to increase the acceptance and protection of the most vulnerable members of areas targeted by the project.

4 Prévention, prise en charge médicale et psychosociale des survivantes VBG

In terms of addressing the 4th cluster objective, holistic care will be provided to all GBV survivors identified, including medical and psychosocial support (as well as legal and economic assistance). The project aims to cover territorial gaps in service provision in the Central North-West.

The project responds to the third principal objectives of the allocation:

3. Renforcer les mécanismes de survie pour les populations les plus à risque du fait de la limitation de mouvement et de la menace sur la sécurité physique

Mercy Corps will provide vocational training, along with IGAs and small business start-up kits, to support the survival mechanism for vulnerable persons at risk of exploitation. To contribute to the reduction of violence, recreational and sport activities for vulnerable youth will be carried out. These activities will target vulnerable returnee and host community individuals living with the trauma of having experienced, witnessed or been exposed to violence. These activities will provide a positive outlet for youth who are at risk of recruitment by armed groups, or violence in general.

Training and group discussions with community leaders and women's groups and the OPJ (judicial police officer) will improve the level of understanding about the nature, causes and consequences of violence using a rights based approach (including reference to human rights, women's and children's rights, and the laws of the Central African Republic). Finally, peace messaging on local radios will facilitate the reduction of violence, for example, to counteract narratives of revenge that are spread through rumors in communities.

**BACKGROUND**

**1. Humanitarian context analysis**

It is estimated that thousands have been kidnapped, tortured and subjected to sexual abuse, abductions and other forms of violence in the Central North West CAR. The conflict patterns in this area have left the population in perpetual fear and resulted in significant displacement. As a consequence, many were forced to flee their homes, increasing already high numbers of IDPs seeking safety in the town centers. Establishing sound protection mechanisms will help to ensure that the province's community networks are strengthened to protect the rights of the population, and provide basic life-saving medical and psychosocial support.

The people in the areas of concern continue to be deprived of basic needs such as shelter, water, food and healthcare. The government is ill-equipped to respond to these needs and unable to provide the most basic social services to conflict affected populations of the region. Vulnerable people, including women, the elderly, orphans, and vulnerable children have endured the brunt of these human rights violations. They have been defenseless in the face of exploitation, abuse and violence. Moreover, the climate of fear engendered by the presence of armed groups has reduced food security and undermined livelihoods, limiting the accessibility to basic goods, thereby increasing their prices. Whole communities are concerned only with their daily survival, unable to enjoy productive, healthy lives. Finally, reintegration of returnees and ethnic minorities could pose to already fragile communities an additional financial, psychological and social strain. All of these contributing factors make strengthening community-level structures paramount in ensuring that grassroots networks and platforms exist to protect rights and build the resilience of these conflict-affected populations.

Gender-based violence is pervasive all over CAR: women and girls are regularly targeted by armed groups and face sexual and physical violence in their homes and communities. As a result of the increase in violence in the country in recent months, women and girls are extremely vulnerable to rape, abduction, exploitation and sexual abuse, and other forms of GBV. Men and boys may also be survivors of GBV and face different challenges in reporting cases and receiving care. Most survivors are unable to access essential medical care, psychosocial support, and other essential services, or reluctant to do so given the stigma and culture widespread in the country silence. Survivors are faced with a lack of socio-economic support, continued trauma, serious health risks and life-long complications. It is clear that this issue requires a scale-up in humanitarian attention. As explained in the Inter-Agency Standing Committee (IASC) Guidelines for Gender-Based Violence Interventions in Humanitarian Settings: "It will be difficult if not impossible to obtain an accurate measurement of the magnitude of the problem in an emergency. All humanitarian personnel should therefore assume and believe that GBV, and in particular sexual violence, is taking place and is a serious and life-threatening protection issue, regardless of the presence or absence of concrete and reliable evidence."

With the support of HCR, Mercy Corps has been providing critical psychosocial services and protection support to vulnerable populations in the Nana-Mambere and Ombella Mpoko since August 2014. Mercy Corps' continued presence in the region makes us uniquely positioned to continue to respond to the situation in the area of concern. Mercy Corps will leverage existing partnerships with community structures in order to support conflict-affected populations. This support will help to alleviate the effects of violations, assist returnees, introduce coping mechanisms and enhance their capacity for resilience, and assist returnees.

**2. Needs assessment**

As assessed by the ongoing Mercy Corps protection monitoring programming, through case studies, interviews with key informants in the community, participatory assessments and field observations, the protection situation in the sub-prefectures of Yaloke, Bouar, and Carnot continues to be critical. In rural areas, ethnic and religious minorities remain at high risk of being killed/held against their will by members of illegal armed groups.

Women suffer all types of GBV, unwanted pregnancies, and are at risk of contracting HIV. Men, on the other hand are routinely killed or used as forced labor in mines or cattle-raising. Male children are often killed while female children are allowed to live, albeit in severe economic deprivation. Consequently, the medical, economic and psychosocial needs of the beneficiaries are gender-dependent. Additionally, the control of resources is 1) dependent on the existence and activities of armed groups in the area 2) on the traditional gender roles in the household, in which women do not have an equal share in the control of, or access to resources.

In at least 13 villages in the targeted 4 sub-prefectures, there are between 400 to 1,200 religious and ethnic minorities, IDPs, and returnees within areas noticeably in the presence of armed groups. Additionally, movements of return and transhumance have been observed, both populations being highly vulnerable to armed groups. Extremely vulnerable individuals with specific protection needs are regularly identified through Mercy Corps' current protection programming, including unaccompanied children, female heads of households, elderly persons, and ethnic minorities including Peuhl communities. These vulnerable individuals often cannot meet their basic needs and lack access to protection services, thus increasing their vulnerability to further protection risks and violations.

Mercy Corps Protection Monitoring activities (including group discussions with Peuhl groups coming from the axe Zawa-Gaga, Bossembele axes) have allowed for the identification of population movements and particular protection alerts, including populations at risk. On the axes Bouar-Bozoum and Bouar-Niem, Mercy Corps current protection committees have identified 15 villages with minority population with significant economic and social limitations.

Return movements have been observed on the axes of Niem-Yelewa and axes Bozoum. In Bouar, due to the decrease in security incidents and activities of social cohesion, return movements are occurring, particularly in the Hausa neighborhood. However, 1,186 persons in this neighborhood remain at risk of violence and human rights abuses perpetrated by Anti-Balaka elements.

For the period January-June 2015, Mercy Corps Protection monitoring activities have identified the following cases in the areas surrounding Bouar, Baoro, Baboua, Yaloke:

- o 135 cases of torture and physical aggression (occurring mostly in 2014, especially in the village of Gaga, where various people were severely tortured by armed groups) ;
- o 22 accusations of sorcery ;
- o 15 cases of sexual aggression ;
- o 49 rape cases with 15 cases resulting in pregnancy, 18 cases with high likelihood of VIH contamination ;
- o 18 cases of forced marriage to members of illegal armed groups ;
- o 274 psychological and emotional aggression ;
- o 47 cases of denial of resources.
- o 24 cases of accompanied minors
- o 428 orphans
- o 14 stigmatized persons
- o 335 elderly persons

### **3. Description Of Beneficiaries**

Direct beneficiaries :

- Individuals held captive in the area of operations
- The most vulnerable survivors GBV (including persons with disabilities, seniors, child mothers, etc.)
- Out-of-school adolescents at risk of sexual and labor exploitation (commercial sexual work, forced marriage, forced labor in the mines)
- The most vulnerable individuals from ethnic and religious minorities

Indirect beneficiaries: ethnic minorities, religious minorities, IDPS, returnees

### **4. Grant Request Justification**

Mercy Corps has worked since 1979 with the goal of helping communities in developing countries transforming crises in opportunities. Currently, Mercy Corps works in 40 countries in Africa, Latin America, the Middle East, and Asia, and employs 4,000 employees. We work in several sectors, including protection, agriculture and food safety, hygiene, health, governance, and youth. Mercy Corps aims to relieve suffering, poverty and oppression by helping people build secure communities, productive, and fair.

Established in CAR in 2007, Mercy Corps operates mainly in the areas of Human Rights and Access to Justice, Child Protection, Women Capacity Building, Water, Sanitation and Hygiene as well as in Food Security, agricultural development and mitigation of conflicts.

Since August 2014, Mercy Corps has implemented Protection monitoring activities, community mobilization and GBV prevention and response, covering the area between Yaloké and Baboua. Listening Centers were established in Yaloké, Baoro, Bouar, and Baboua to provide a holistic response to survivors of GBV, follow up with Protection cases, and monitor the movement of populations. From January to June 2015, 560 survivors have consulted these listening centers. Community-based mechanisms were also established with 22 Protection Committees and with 21 Community Counselors for protection monitoring and referral.

In 2014, 192 microprojects were established in Bangui, Bouar, Bangassou, and Rafai. In terms of NFIs 2014, Mercy Corps distributed NFIs to 137 Peuhl IDPs, and in 2015 Mercy Corps distributed 400 NFI kits, including 200 emergency kits for returning IDPs in the Nana-Mambaré. Elsewhere in Africa and at the global level, Mercy Corps has significant experience leading cash-based responses and IGA and vocational trainings to support livelihoods recovery.

## 5. Complementarity

Mercy Corps has partnered with UNHCR since August 2014 to provide access to essential GBV services, monitor protection issues and strengthen community-based protection response. As a result of this, Mercy Corps has gained respect and trust within communities in this part of CAR, and has already built strong relationships with key stakeholders and collected quality protection-monitoring data. Mercy Corps' proposed intervention will therefore reinforce gains made from current programming in Nana-Mambéré and Ombella M'poko.

The other GBV actor in the area, Save the Children, works on GBV cases affecting children in Bouar. While medical and psychosocial support is given to minors by Mercy Corps through our Listening Centers and partners, cases concerning minors are referred to Save the Children for follow up.

The current proposal aims at expanding the protection coverage on axes that are not targeted currently by protection actors, thereby ensuring complementarity of project activities with existing programs.

Assumptions & risks:

- The security situation will not deteriorate in the medium-term, and will not stop the process of IDP returning to their homes. Occasional security incidents will likely impede movement for protection teams, causing delays.
- Likely that numbers of Protection Committees will fluctuate in the medium-term, especially for nomad Peuhl groups who are vulnerable but are not captive in villages.
- Likely that for some beneficiaries, individual case follow up will be impossible after the initial provision of assistance due to them opting to leave the country.
- Local authorities remain supportive throughout the project implementation.

**Monitoring & Reporting plan**

The proposed project will use project monitoring tools, such as monthly reports from staff and partners, tests and training assessments, semi-structured interviews, and case studies. Mercy Corps will use additional tools such as Quality Criteria checklists, protection analysis, and contribute monthly to databases for GBV-IMS, and Identification, Tracing, Documentation and Reunification (IDTR), which monitors services provided to unaccompanied children.

A data collection and analysis system will be implemented at the start of the project. Data coming from various sources (protection monitors, individual interviews, community dialogue, key informant interviews, direct observation) will be triangulated and evaluated so as to produce regular mapping and contextual analysis products. Considering the urgency of some protection cases, individual alerts will be shared with the concerned actors, on a need to know basis.

Protection Monitoring will work in the following manner: 100 Protection Committee members and 25 Community Counselors, who are inhabitants on the axes road, alert Mercy Corps Monitors and Community Mobilizers on a weekly basis on Protection incidents and population movements.

To mitigate the underlying socio-cultural factors contributing to GBV, Mercy Corps will continue to target community leaders, protection committees, and OPJ (Judicial Police Officers). 540 cases were referred by these actors in the area of concern over a recent six month period, attesting to their receptivity of offsetting norms of gender violence in CAR society. Monthly meetings are held with these leaders and protection committees to understand trends in targeted areas (rise in a certain typology of GBV), which later inform following awareness raising sessions.

A total of 200 NFI kits will be distributed to vulnerable households, including to children head of households. For monitoring purposes, protection committees will participate in the selection of target vulnerable households. NFI kits have been favored over cash distribution as many items are not available in the local market. However, supplies used in NFI kits will be procured locally wherever possible. Protection Committees will monitor the distribution, provide follow-up monitoring, and support the process itself alongside the Community Mobilizers who will be responsible for the distribution.

A baseline study will be undertaken at the beginning of the project. The study will collect information on violent incidents that occurred in the areas of concern in the last 6 months in order to create a baseline for the violence reduction component of the project. Weekly data will then be collected on protection incidents for 1) protection response 2) improvement of the situational awareness 3) update the database of violent incidents & improve analysis.

The efficiency of Protection activities will be judged through follow up by psychosocial officers, who monitor the progress of survivors and their adjustment and social reintegration, not only through the survivors regular visits to the Listening Center, but also through IGA and discussion groups. Along with the GBVIMS that is routinely filled out in listening centers, individual cases are monitored through counseling forms to gauge their progress.

A Community Accountability Reporting Mechanism (CARM) will be implemented, with regular feedback meetings organized in the communities. A mid-project internal progress evaluation will be carried out.

**Accountability to Affected Populations**

Contextual analysis has been collected and analyzed with the direct input from community members--women's groups, community leaders, and youth.

Mercy Corps will set-up from the start of the project a Community Accountability Reporting Mechanism (CARM): a safe, confidential, transparent and accessible reporting mechanism that will ensure that beneficiaries can report disturbing situations or behaviors related to Mercy Corps staff (team member misconduct, instances of sexual exploitation and abuse as well as program implementation concerns).

The CARM system will enable Mercy Corps to increase accountability, empower beneficiaries, improve program impact and quality, capture important information, detect early warning signs, build stronger relationships with the communities, provide vulnerable people with a venue for anonymous feedback, and discourage corruption, theft and abuse.

In terms of information sharing, regular meetings with project beneficiaries will be carried out with the support of Protection Committees.

Given the sensitive context and the severe Protection situation, Mercy Corps will hire a local Senior Protection Expert with experience in negotiation with armed groups and the implementation of Do No Harm.

In terms of an Exit Strategy, protection mechanisms contribute directly to the desired end-state of secure communities, while enabling sustainable peacebuilding initiatives to prosper. Protection Committees trained during this project will be able to continue to refer cases of GBV or Human Rights abuses to Listening Centers, medical services, or other services even after the end of the project, thereby allowing continuity of impact.

**Implementation Plan**

The project does not include components to be implemented by partners.

Mercy Corps will reinforce its presence in the regional and national Protection Clusters and will provide regular information (monthly reporting for analysis and ad-hoc alerts) about project activities and protection alerts/analysis, for regional and national protection coordination bodies. This includes cooperation with other agencies in the cluster regarding all aspects of the project, including the composition of dignity kits – although currently it should be emphasized that there are no norms regarding such kits at the local cluster – kit composition is based on needs.

Additionally, Mercy Corps will collaborate with health, security, and protection partners to reinforce the referral system (avoid gaps and duplication of services).

**Justify Chosen Gender Marker Code**

The current Mercy Corps Protection monitoring in the area of Yaloke and Bouar has allowed for an in-depth needs assessments in order to understand risk factors and risk reduction variables for the most vulnerable sectors of the population. The needs assessment was designed to include both genders and various economic and social categories. However, the proposed project beneficiaries are selected on the basis of need, not gender, consequently both sexes are equally included in all project activities, from emergency assistance to income-generating training/support and community-dialogues. To contribute to gender equality, protection committees will be mixed in order to promote and gendered analysis of acute problems in the community. The alert system will incorporate the risk perception of women and young men to guide response to relevant civilian protection of bodies. Vulnerable women, girls will receive IGA training for economic independence, as well as young men. The project will bring together men leaders and women groups for dialogue and training on gender issues. Mercy Corps will train Judicial Police in the guiding principles of GBV interventions and sexual assault victim interview techniques for law enforcement, as well as Central African laws.

The project therefore aims to circumvent the traditional and conflict-related barriers to gain gender equitable access to the most vulnerable individuals, with a clear guideline of impartiality and neutrality.

**Protection Mainstreaming**

Mercy Corps listening centers follow the guiding principles of GBV interventions (informed consent, dignity, consent, security of the survivor). Likewise, there is impartial access for all populations wishing to visit the listening centers, such as men, who have previously received support through Mercy Corps listening centers.

**Country Specific Information****Safety and Security**

The security situation in Center and North- West is characterized by the presence of a significant number of small armed groups, village and neighborhood-based, that engage in various human rights violations against the civilian population and in opportunistic road robberies and other criminal activities. The current security monitoring systems do not capture the casualties/incidents in the remote areas but based on their modus operandi of the illegal armed groups, it is highly likely that the civilian population still suffers torture, rape, financial-motivated kidnappings in such locations. The project will strengthen the capacities of local staff and protection committees to build situational awareness in the areas of operations.

On a daily basis, Mercy Corps undertakes security risk assessments for its operations in sensitive areas, reinforcing clear security guidelines for staff.

**Access**

Through the work with community members and leaders, protection committees, and authorities, Mercy Corps has built and reinforced communication channels with communities facing the same type of risks as the ones targeted in the current proposal. Additionally, through the current protection mainstreaming project, Mercy Corps has established contacts with members of the communities in the axes of interest in order to lay the groundwork for protection interventions. To date, no significant security incident or community resistance took place.
