

Addendum No 2
to the Standard Administrative Arrangement
between
the Government of Sweden, represented by the Swedish International Development Cooperation Agency
and
the United Nations Development Programme

The Government of Sweden, represented by the Swedish International Development Cooperation Agency (hereafter referred to as the "Donor") and the United Nations Development Programme (hereinafter referred to as "UNDP") acting as Administrative Agent of the Joint Programme entitled "*Strengthening the Rule of Law in the Opt – Justice and Security for the Palestinian People*" (hereinafter referred to as the "Joint Programme") on behalf of itself and all the Participating UN Organizations (hereinafter referred to as the "Administrative Agent") have agreed as follows:

Whereas in Article I, Paragraph 1 of the Standard Administrative Arrangement signed between the Donor and the Administrative Agent (hereinafter referred to collectively as the "Parties") on 30 May 2014, the Donor has made a contribution of **Thirty Nine Million Swedish Kronor (SEK 39,000,000)** "and such further amounts as it may decide".

In 2015 the Donor committed itself to make an additional contribution of **Ten Million Swedish Kronor (SEK 10,000,000)**, to support the Joint Programme, through the amendment signed on 27 May 2015 ("Addendum 1")

The Donor has now agreed to make an additional contribution to support activities of the Joint Programme ~~through the present document ("Addendum 2").~~

Whereas the Steering Committee of the "*Strengthening the Rule of Law in the Opt: Justice and Security for the Palestinian People*" has agreed to extend the Joint Programme until 30 April 2018 at a meeting held on 22 February 2017.

The Standard Administrative Arrangement between the Participants is therefore modified as follows:

Section I Paragraph 1. The donor accepts to make an additional contribution of **Fourteen million Swedish kronor (SEK 14,000,000)**. **The total contribution now therefore amounts to Sixty Three Million Swedish Kronor (SEK 63,000,000) following the signature of this Addendum 2.**

Section I Paragraph 2. The Donor shall deposit the Contribution by wire transfer to the following account:



The new end date of the Joint Programme fund is **30 April 2018**.


All other terms and conditions of the Standard Administrative Arrangement and its Amendments remain unchanged. This Addendum shall enter into effect on the date of signature by the Parties.
