## INTRODUCTION

This Consolidated Annual Financial Report of the **JP Bosnia and Herzegovina CRSV Fund** is prepared by the United Nations Development Programme (UNDP) Multi-Partner Trust Fund Office (MPTF Office) in fulfillment of its obligations as Administrative Agent, as per the terms of Reference (TOR), the Memorandum of Understanding (MOU) signed between the UNDP MPTF Office and the Participating Organizations, and the Standard Administrative Arrangement (SAA) signed with contributors.

The MPTF Office, as Administrative Agent, is responsible for concluding an MOU with Participating Organizations and SAAs with contributors. It receives, administers and

manages contributions, and disburses these funds to the Participating Organizations. The Administrative Agent prepares and submits annual consolidated financial reports, as well as regular financial statements, for transmission to contributors.

This consolidated financial report covers the period 1 January to 31 December **2018** and provides financial data on progress made in the implementation of projects of the **JP Bosnia and Herzegovina CRSV Fund**. It is posted on the MPTF Office GATEWAY (<http://mptf.undp.org/factsheet/fund/JBA00>).

The financial data in the report is recorded in US Dollars and due to rounding off of numbers, the totals may not add up.

## 2018 FINANCIAL PERFORMANCE

The table below provides an overview of the overall sources, uses, and balance of the **JP Bosnia and Herzegovina CRSV Fund** as of 31 December 2018. Financial information for this Fund is also available on the MPTF Office GATEWAY, at the following address:

The cumulative source of funds was US\$ **1,792,816**. Of this amount, US\$ **1,773,909** has been net funded to **4** Participating Organizations, of which US\$ **1,750,642** has been reported as expenditure. The Administrative Agent fee has been charged at the approved rate of 1% on deposits and amounts to US\$ **17,918**.

## SOURCES AND USES OF FUNDS

As of 31 December **2018**, 2 contributors deposited US\$ **1,791,830** in contributions and US\$ **986** was earned in interest.
