Increase employers' awareness at the WISE /TOT workshop</b></p>	<p>In August 2010 a WISE (Work Improvement in Small Enterprises)/ TOT (Training of Trainers) workshop was organized by the Mongolian Employers' Federation (MONEF) in Ulaan Baatar. The ILO Senior Specialist on OSH gave a presentation on "pandemic influenza prevention at the workplace" to raise awareness and promote influenza pandemic preparedness and prevention measures at the workplace.</p>	<p><b>100%</b></p>

The training mechanism was designed, and an action check-list was developed. The venue and agenda are being set. Participants are being recommended by an NGO in the target area.	<b>30%</b>
<b>8. Study and analyze the impact of the 2009 pandemic influenza on migrant workers and the OSH situation in Thailand and other countries in the region</b>	The available information was collected and a draft report has been prepared.	<b>30%</b>

Document the workplace experiences during the 2009 pandemic</b>	A national consultant has been recruited to develop the document, which will include project achievements, lessons learned and good practices, as well as develop recommendations for future action. Contents are currently being designed and the collection of relevant information has started.	<b>20%</b>
<b>Qualitative achievements against outcomes and results:</b>		
<p>The progress of the above listed project activities is in line with the work plan, with some adjustments made to match the current AHI sentiment. These initial activities are geared towards the longer term objective of integration into existing ILO programmes and platforms for sustainability purposes. The Project aims at gradually integrating its influenza training and pandemic prevention and preparedness activities developed for the workplace into the national OSH training and labour administration systems, in respect to SMEs and informal economy workplaces especially.</p>
