

Uruguay One UN Coherence Fund

**Amendment No. 1 to the
Memorandum of Understanding
between
the International Organization for Migration (IOM),
the United Nations Resident Coordinator
and
the United Nations Development Programme
regarding the Operational Aspects of the Uruguay One UN Coherence Fund**

WHEREAS, Participating UN Organizations developed the “*One Programme 2007-2010. Building Capacities for Development between the Government of Uruguay and the United Nations System in Uruguay*” (“One Programme Document”), signed on 19 October 2007, and agreed to establish a coordination mechanism, the “One Programme Steering Committee” to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government for the implementation of the One Programme;

WHEREAS, the Participating UN Organizations that have signed the Memorandum of Understanding have agreed to establish a common development fund (hereinafter referred to as the “Uruguay One UN Coherence Fund”) that, under the leadership of the Resident Coordinator, will support the coordinated resource mobilization, allocation and disbursement of donor contributed resources for the unfunded elements of the One UN Programme;

WHEREAS, the Participating UN Organizations have now developed a **United Nations Development Assistance Framework (UNDAF) in Uruguay for 2011-2015**, as part of their respective development cooperation with the Government of Uruguay, and concluded the Amendment No 1 to their Memorandum of Understanding;

The Memorandum of Understanding between the International Organization for Migration (IOM), the Resident Coordinator and the United Nations Development Programme (acting as Administrative Agent of the Uruguay One UN Coherence Fund) is therefore modified as follows:

Preamble:

WHEREAS, the Participating UN Organizations to the Uruguay One UN Coherence Fund have signed the Amendment No 1 to the Memorandum of Understanding relating to the Operational Aspects of the Uruguay One UN Coherence Fund (attached hereto as Annex 1);

Agreement:

3. IOM agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding and its Amendment No. 1 entered into between the Participating UN Organizations, the Resident Coordinator and UNDP, attached hereto as Annex I, which is an integral part of this Memorandum.

All other terms and conditions of the Memorandum of Understanding remain unchanged.
