

Uruguay One UN Coherence Fund

**Amendment No. 1 to the
Memorandum of Understanding
between
Participating UN Organizations,
the United Nations Resident Coordinator
and
the United Nations Development Programme
regarding the Operational Aspects of the Uruguay One UN Coherence Fund**

WHEREAS, Participating UN Organizations developed the “*One Programme 2007-2010. Building Capacities for Development between the Government of Uruguay and the United Nations System in Uruguay*” (“One Programme Document”), signed on 19 October 2007, and agreed to establish a coordination mechanism, the “One Programme Steering Committee” to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government for the implementation of the One Programme;

WHEREAS, the Participating UN Organizations that have signed the Memorandum of Understanding have agreed to establish a common development fund (hereinafter referred to as the “One UN Coherence Fund for Uruguay”) that, under the leadership of the Resident Coordinator, will support the coordinated resource mobilization, allocation and disbursement of donor contributed resources for the unfunded elements of the One UN Programme;

The Participating UN Organizations have now developed a **United Nations Development Assistance Framework (UNDAF) in Uruguay for 2011-2015**, as part of their respective development cooperation with the Government of Uruguay.

The Memorandum of Understanding between the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme (acting as Administrative Agent of the Uruguay One UN Coherence Fund) is therefore modified as follows:

Preamble:

WHEREAS, ECLAC, FAO, ILO, ITC, OHCHR, UNAIDS, UNCTAD, UNDP, UNEP, UNESCO, UNFPA, UNICEF, UNIDO, UNODC, UNOPS and UN Women (hereinafter referred to collectively as the “Participating UN Organizations”) have developed a United Nations Development Assistance Framework (UNDAF) in Uruguay for 2011-2015 (hereinafter referred to as the “UNDAF 2011-2015”), and as part of their respective development cooperation with the Government of Uruguay, as more fully described in the detailed UNDAF 2011-2015 document signed on 20 May, 2010, attached as Annex A (hereinafter referred to as the “UNDAF 2011-2015 Document”), and have agreed to establish a coordination mechanism (hereinafter referred to as the “One UN Coherence Fund Steering Committee for the UNDAF 2011-2015”) to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government for the implementation of the UNDAF 2011-2015;

WHEREAS, the Participating UN Organizations have agreed that they should adopt a coordinated approach to collaboration with donors who wish to support the implementation of the UNDAF 2011-2015 and have developed a UNDAF 2011-2015 Document to use as the basis for mobilising resources for the UNDAF 2011-2015, and have further agreed that they should offer donors the opportunity to fund the UNDAF 2011-2015 and receive reports on the UNDAF 2011-2015 through a single channel;

WHEREAS, the One UN Coherence Fund for Uruguay will complement other channels for the transfer of donor resources to support implementation of the UNDAF 2011-2015;

All subsequent references to the "One Programme Document" in the Memorandum of Understanding Sections I – VII are hereby amended to the "UNDAF 2011-2015", and those to the "One Programme Steering Committee" are amended to the "One UN Coherence Fund Steering Committee of the UNDAF 2011-2015", while Annex A is replaced by the UNDAF 2011-2015 Document.

All other terms and conditions of the Memorandum of Understanding remain unchanged.
