RAWA's main office is located in Xarardheere town. RAWA was implementing GFD and BSFP programs in the same areas in partnership of WFP before WFP vacated the district thus RAWA has field offices at all the sites with number of staff ranging from 2 to 3 person per site whose services will be used to implement this project at their respective sites. The project will be monitored daily, weekly, biweekly and monthly by different officers in the project along with the community. Rasawad Welfare Association (RAWA) with support of the community participation will form project implementation committee (PIC) from the community that will compose of 7 members (3 women and 4 men) of target beneficiaries in all sites. Both quantitative and qualitative data will be collected through methodological use of questionnaires, measurement, observation, focus group discussion, primary and secondry data review, individual and group interview. The monitoring will look at improvement in response to any noted shortfalls where progress of project activities will be recorded. The indicators of the number of drums/liters delivered daily will be monitored with NGO staff at sites, vendors and beneficiaries. Evaluation before, at mid- and end-term of the project will be carried out where the baseline will be recorded at the beginning including market food prices, at mid-point, we will look at the progress the project has made negatively or positively on the lives of the people and environment while at the end will look at both negative and positive impact project implementation might have caused with recommendation and same will be shared at Nairobi and WASH cluster meetings and reports.
