

**Amendment No 1 to the
Memorandum of Understanding
between
the International Organization for Migration (IOM),
the United Nations Resident Coordinator
and
the United Nations Development Programme (UNDP)
regarding the Operational Aspects of the One UN Fund for Tanzania**

WHEREAS the Memorandum of Understanding (hereinafter referred to as "Memorandum") between the International Organization for Migration (hereinafter "IOM"), the Resident Coordinator for the United Nations System in Tanzania (hereinafter "Resident Coordinator") and the United Nations Development Programme, as Administrative Agent of the One UN Fund for Tanzania, (hereinafter "UNDP") was concluded on 4 April 2008;

WHEREAS, the Participating UN Organizations to the One UN Fund for Tanzania have now developed the **July 2011 – June 2015 United Nations Development Assistance Plan (UNDAP)**, as part of their respective development cooperation with the Government of the United Republic of Tanzania;

WHEREAS, the Participating UN Organizations have concluded an Amendment No 1 to the Memorandum of Understanding and thereby extended the duration of the One UN Fund until for Tanzania until 31 December 2015, based on the development of July 2011- June 2015 UN Development Assistance Plan, (attached hereto as Annex I);

The Memorandum of Understanding between the International Organization for Migration (IOM), the Resident Coordinator and the United Nations Development Programme (acting as Administrative Agent of the Tanzania One UN Fund) is therefore modified as follows:

Agreement:

3. IOM agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding and its Amendment No 1 entered into between the Participating UN Organizations, the Resident Coordinator and UNDP, attached hereto as Annex I, which is an integral part of this Amendment.

All other terms and conditions of the Memorandum of Understanding remain unchanged.
