

**Memorandum of Understanding
between
the International Development Law Organization (IDLO)
and
the United Nations Development Programme (UNDP)**

regarding the Operational Aspects of the Peacebuilding Fund (PBF)

This Memorandum of Understanding (hereinafter referred to as “Memorandum”) is concluded between the International Development Law Organization (IDLO), an inter-governmental organization having its headquarters at Viale Vaticano, 106 00165 Rome, Italy, and the United Nations Development Programme, a subsidiary organ of the United Nations, having its Headquarters at One United Nations Plaza, New York, New York, as Administrative Agent of the Peacebuilding Fund (hereinafter “UNDP”).

WHEREAS, the Recipient UN Organizations to the PBF have signed a Memorandum of Understanding relating to the Operational Aspects of the PBF (attached hereto as **Annex I**).

WHEREAS, IDLO wishes to continue to participate in the PBF and receive funds on the same terms as the Recipient UN Organizations.

WHEREAS, The United Nations through its Assistant Secretary-General for Peacebuilding Support authorizes UNDP as Administrative Agent to conclude this Memorandum with IDLO for its participation in the Fund.

NOW, THEREFORE, IDLO and UNDP hereby agree as follows:

1. IDLO warrants and confirms that it has entered into relevant basic agreements with the governments of the countries where it will operate in connection with the PBF, as a basis for its activities.
2. IDLO warrants and confirms that it has privileges and immunities in respect of its personnel and assets consistent with those of the Recipient UN Organizations in the countries where it is to undertake activities in connection with the PBF, including functional immunity of its personnel and assets, and immunity from legal process and from search and seizure.
3. IDLO agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding entered into between the Recipient UN Organizations and the UNDP attached hereto as Annex I, which is an integral part of this Memorandum.
4. For Notices under this Memorandum, the addresses of UNDP and IDLO are as specified in **Annex II** hereto.

5. This Memorandum shall enter into force upon signature by the authorized officials of IDLO and UNDP and shall continue in force and effect until it expires or is terminated.
