(maximum 1500 characters) *	<p>Hiraaan has been a major producer of cereal crops, particularly sorghum, but due to water stress production was reduced drastically. The post-Deyr season recorded only 477MT of cereals, equivalent to about 29% of the previous season (ref: Deyr FSNAU assessment). This led to a severe crop failure in all agro-pastoral zones of the district. Sorghum inflow from the neighboring Bay Region also reduced considerably due to crop failure and civil insecurity. □</p> <p>□ Between 23 and 27 Dec 2010, Action Against Disaster (AADSOM) and other local NGOs in Hiraaan region carried out a joint drought emergency assessment that focused to find out the impact of the drought on the food assistance cluster position in Hiraaan, especially in the remote areas on both the western and eastern sides of Shabelle river. This was followed up with a rapid needs assessment on the drought situation of few villages in Beletweyn and Jalalaqsi between April and May, 2011. The findings were</p>

(maximum 1500 characters) *	<p>Hiraaan is one of the regions in south central Somalia, served by the Shabelle river and its formally divided into four districts: Belet Weyne (Beled Weyn), Bulo Burto (Buulo Burdo or Bula-Brif), Jalalaqsi and Matabaan. The region is considered mostly agro-pastoralist zone with livestock keeping and small-scale farming (mostly using irrigation) as the main economic and livelihood activity in the region. □</p> <p>The team visited 19 agro-pastoralist and pastoralist villages where they found 12,090 households are AFLC while 15,000 households HE of which 34.8% were women and 48.9% children. Pastoralists communities visited were: Farlibaax – celcade areas, Buq-goosar – Eldheer area, Mukoyle - Dheriyow area, Buqabale - Wabxo area, Biyoneef - Dabadeey area, Haraale - Raangabo area, Bilaal - Biyokulul area, Shaw - Dheen area and El-Baar - Wardhabeel area. □</p>

(W) Implementation Plan* Describe how you plan to implement these activities (maximum 1500 characters)	<p>This proposed intervention is designed to cover a total of 17 drought affected villages covered by the assessment with 14, 161 target beneficiaries of 2360 HHs (see attached list of beneficiaries) with 297.45 MT of assorted food commodities. Each HH will be receiving 50kgs of maize, 10kgs of cowpeas and 3litres of vegetable oil per month worth \$48.09 per basket. □</p> <p>□ AADSOM proposes to implement the food security project in a total of 17 villages in 3 different districts namely Beletweyn, Bulo Burté and Jalalaqsi. The project will fall under the responsibility of the Project Manager based in Beletweyn and he will work with project officers, food monitors and other volunteers. In order to address the food security needs AADSOM will use participatory food targeting and distribution where the local leaders of the target community will be involved. This will lay down clear targeting criteria in</p>

Monitoring will be done on routine basis, the 3 project officers who are in-charge of a district will be responsible for monitoring the traders by ensuring that quality food standard is brought by the supplier, the food is packed and stored in well maintained and clean stores, the quantity and quality of the food should be as specified in the contract/tender documents. Equally, the project officer will ensure that the process of identification of beneficiaries, registration, and distribution of the voucher cards are well coordinated such that justice is employed and the most vulnerable is targeted.

Distribution of the food supplements will be done in partnership with the local stakeholders, however, it is the responsibility of the food monitors to ensure that the food goes to the rightful beneficiaries and the correct amount of ration is supplied to each Head of Household. Equally, the food monitors will ensure that the food being supplied is the same quality approved by the project officer.

Post distribution monitoring (PDM) will be done in each village by the project officer by using a standard questionnaire at HH level and FGDs at village level and site visits. The PDM will try to find out the quantity, and quality of the food, the place and timing of distribution, any complaints arising and how it was resolved.
