3. BACKGROUND AND NEEDS ANALYSIS (please adjust row size as needed)

(A) Describe the project rationale based on identified issues, describe the humanitarian situation in the area, and list groups consulted. (maximum 1500 characters) *	Persistent heavy fighting in Mogadishu between AMISOM/TFG troops and Al Shabaab has resulted in mass displacement of the populations to safer areas in and outside Mogadishu. The situation is tense with sporadic shelling in the residential areas. Defense lines of AMISOM/TFG and Al Shabaab are located along the main route to Bakara Market resulting in many civilians getting injured in crossfire. UNHCR reported that at least 17,000 displacements have occurred from Mogadishu since 23 February, of whom 8,000 fled the city and another 9,000 moved to calmer districts in Mogadishu including the 10 target IDP camps. The intensifying conflict has led to unprecedented displacements in which women and girls are the worst affected. They are living in deplorable conditions without basic shelter provision and household items. Furthermore, women and girls do not have access to sanitary pads and possess limited clothing. This can lead to embarrassment and affects their dignity. Groups consulted are TFG administration in Mogadishu, IDP committees, humanitarian organizations operating in the area and UNHCR. The 10 camps were chosen based on

(maximum 1500 characters) *	There are 13,260 IDPs in the following 10 IDP camps in Mogadishu: Siyaad b, Qeyre Camp, Cali-nuur Camp, Nasteexo Camp, Mino Kaam, Rajo Kaam, Amin Kaam, Fatxi Kaam, Kamaal Kaam and Towhid Kaam. 5,087 of them are women and girls. The project targets the most vulnerable 2,000 women and girls who are newly displaced and live in precarious conditions. The target beneficiaries needs are clothing and underwear, basic hygiene kits and minimum NFIs including:  Sanitary cloth measuring 150cm x 170cm, 180 gr per sq. metre, raised/combed on both sides, cut into 2 meter lengths (3m2 per piece)  A dozen detergent satchets, OMO 100 gr  6 pcs of bath soap  3pcs of underwear Garbasaar (cloth) 

(maximum 1500 characters)	SSWC is a credible organization and has provided various humanitarian interventions since 1992. The organization has competent staff members who are able to work in the volatile conflict situation where there is limited humanitarian access. The organization has offices in Mogadishu, Adado, South Galkayo and Nairobi. In February 2011, SSWC was awarded \$40,400 from ERE- CHF for distribution of dignity kits to 1,500 women displaced by conflict in Mogadishu and the project was completed in time and as per plan. In addition SSWC has implemented several projects of different nature such as:  Population movement tracking & protection monitoring project in Mogadishu in partnership with UNHCR/NRC (on-going)  "Give Peace and Reconciliation a Chance" supported by UNPOS in Galkayo, Mudug and Adado Galgaduud regions in 2011 at a cost of US \$30,400 

(W) Implementation Plan* Describe how you plan to implement these activities (maximum 1500 characters)	SSWC staff will visit the target IDP camps in Mogadishu and meet IDP committee members as well as the newly displaced IDP women heads of households. By working with the committees, SSWC will ensure that the most vulnerable are selected as beneficiaries. This will include women and girls who cannot work or with health problems, elderly, single headed households, disabled and orphans. Once the list has been prepared, the distribution will be advertised on local radio and beneficiaries will be called for the distribution. On receipt of the items, their fingerprints and phone number will be taken. Following this, Post Distribution Monitoring will be undertaken and SSWC project staff will visit the beneficiaries to assess impacts using verifiable indicators. Procurement of hygiene kits and clothes and underwear will take place in Mogadishu while 2,000 NFI (jerry cans, plastic sheets, kitchen sets, blankets etc) will be donated by UNHCR. Hygiene kits, clothing and underwear will be procured locally in Mogadishu.

Project monitoring will be continuous and includes both monitoring of the impact of the implemented activities, as well as assessing the result indicators. The project coordinator and field staff will carefully monitor the project on a daily basis and document all activities to ensure effective implementation. Post Distribution Monitoring in partnership with UNHCR and Intersos will be carried out and the costs covered by UNHCR while SSWC will provide the distribution reports. The project manager will produce monthly progress reports on activities till their completion. The monitoring from the outset of the project will be supported by the use of a logical framework. The project staff will be present in the entire project duration. Stakeholders including target beneficiaries, TFG administration representatives, IDP committees, women household heads and SSWC staff. All stakeholders will contribute to review the project progress in order to ascertain the set bench-marks. The project manager and board of directors will ensure that monitoring and evaluation information in an accurate and consistent way, and that reporting is done in a timely manner on a monthly basis. This documentation will be compiled for success stories and includes both challenges and lessons learnt. Evaluation will be done at the end of the project to determine whether the project has achieved its intended objectives. All monitoring, final and evaluation reports as well as photos and beneficiary phone numbers will be shared with OCHA. All 10 camps are in the TFG controlled areas.
