

## **Pakistan One Fund**

**Amendment No. 1 to the  
Memorandum of Understanding  
between  
Participating UN Organizations,  
the United Nations Resident Coordinator  
and  
the United Nations Development Programme  
regarding the Operational Aspects of the Pakistan One Fund**

**WHEREAS**, the Government of Pakistan requested the members of the United Nations Country Team, chaired by and under the leadership and coordination of the United Nations Resident Coordinator in Pakistan, to develop a single framework for their activities in support of national development priorities in accordance with the Pakistan national priorities and, accordingly, the members of the UNCT prepare the "*Delivering as One: One Programme Document 2008-2010*" ("One Programme Document"), signed on 9 February 2009;

**WHEREAS**, the Participating UN Organizations that signed the Memorandum of Understanding dated 17 June 2008 agreed to establish a joint development fund (hereinafter referred to as the "Pakistan One Fund"), under the leadership of the Resident Coordinator, that facilitates the coordinated resource mobilization, allocation and disbursement of donor contributed resources for the unfunded elements of the One Programme Document, starting on 1 June 2008 and ending on 31 December 2010, to coincide with the United Nations Development Assistance Framework (UNDAF);

The High Level Committee has now extended the One Programme Document until 31 December 2012.

The Memorandum of Understanding dated 17 June 2008 between the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme (acting as Administrative Agent of the Pakistan One Fund) is therefore modified as follows:

### **Preamble:**

**WHEREAS**, members of the UNCT that have signed this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations") have agreed to establish, a joint development fund (hereinafter referred to as the "Pakistan One Fund"), under the leadership of the Resident Coordinator, that will facilitate the coordinated resource mobilization, allocation and disbursement of donor contributed resources for the unfunded elements of the One UN Programme, **starting on 1 June 2008 and ending on 31 December 2012**, to coincide with the current United Nations Development Assistance Framework (UNDAF), which will be renewed with the start of a new UN programme planning cycle;

*All other terms and conditions of the Memorandum of Understanding dated 17 June 2008 remain unchanged.*
