## Viet Nam One Plan Fund II

Amendment No. 2 to the
Memorandum of Understanding
between
Participating UN Organizations,
the United Nations Resident Coordinator
and

the United Nations Development Programme regarding the Operational Aspects of the Viet Nam One Plan Fund II

WHEREAS, the Government of Viet Nam (hereinafter referred to as the "Government") requested the members of the United Nations Country Team in Viet Nam (hereinafter referred to as the "UNCT"), under the leadership of the United Nations Resident Coordinator in Viet Nam, as the Co-Chair of the One Plan Steering Committee, as defined herein, (hereinafter referred to as the "Resident Coordinator"), to develop a single framework for their activities in support of national development priorities in accordance with the Hanoi Core Statement on Aid Effectiveness, and accordingly the members of the UNCT prepared a One UN Programme Document dated 20 June 2008 (hereinafter referred to as the "One Plan II"), as may be amended from time to time and attached hereto as ANNEX A;

WHEREAS, members of the UNCT signing a Memorandum of Understanding in November 2008 (hereinafter referred to collectively as the "Participating UN Organizations") agreed that they should, under the leadership of the Resident Coordinator, adopt a coordinated approach to collaboration with donors who wish to support the implementation of the One Plan II, and have developed a joint One Plan Fund II (hereinafter referred to as the "Fund"), starting on 20 June 2008 and ending on 31 December 2010, to use as the basis for mobilizing resources for the One Plan II; and have further agreed that they should offer donors the opportunity to contribute to the Fund and receive reports on the Fund through a single channel;

**WHEREAS**, the One Plan Steering Committee, the Expanded OPFMAC and the UNCT in November 2010 agreed to extend the duration of the One Plan II until 30 June 2011 and concluded an Amendment No 1 to the Memorandum of Understanding;

The One Plan Steering Committee, the Expanded OPFMAC and the UNCT have now agreed to extend the duration of the One Plan II until 30 June 2012.

Accordingly, the Memorandum of Understanding between the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme, represented by the Multi-Partner Trust Fund Office acting as Administrative Agent of the Viet Nam One Plan Fund II, is therefore modified as follows:

WHEREAS, the Participating UN Organizations agreed that they should, under the leadership of the Resident Coordinator, adopt a coordinated approach to collaboration with donors who wish to support the implementation of the One Plan II, and have developed a joint One Plan Fund II (hereinafter referred to as the "Fund"), starting on 20 June 2008 and ending on 30 June 2012, to use as the basis for mobilizing resources for the One Plan II; and have further agreed that they should offer donors the opportunity to contribute to the Fund and receive reports on the Fund through a single channel;

All other terms and conditions of the Memorandum of Understanding remain unchanged.
