

## Project Document

### **Executive Summary**

The project will focus on increasing access to employment for young people living with HIV by establishing market linkages and strengthening their capacity towards agro-business and construction related skills. More specifically the training programme will cover a number of major skills including carpentry, plumbing, brick laying, etc as well as entrepreneurial competencies, marketing skills, promoting products and services, market surveys, financial skills, legal environment and the preparation of Business Plans.

Participants will also receive individualised one-on-one counselling with the counsellors to address the specific needs of each individual enterprise. After the training, each participant is expected to prepare an enterprise business plan. This would establish the right steps to access required financing, start a new business and also enhance growth.

Alternatively, the beneficiaries will be given seed funds to engage in livelihood or income generating activities

### **Situation Analysis**

In Sierra Leone where it is estimated that there are over 50,000 People living with HIV considerable advances have been made regarding involvement and representation of PLHIV in the national response, most notably with the inauguration of NETHIPS (Network of HIV Positives in Sierra Leone) Secretariat **by the First Lady** of the Republic of Sierra Leone. NETHIPS is a legally registered umbrella organization representing over 40 PLHIV groups (5,000 members), with young people making up a considerable size of its membership.

One key issue frequently brought forward by NETHIPS and its members is the need for access to employment opportunities for people living with HIV to generate disposal income to support their specific needs and the needs of their family.

Access to employment is critical for all people in Sierra Leone contributing to poverty alleviation and overall economic growth. For people living with HIV it is particularly critical as the burden of HIV-related illness and death on family members leads to food insecurity, while the nutritional needs for immune-suppressed individuals are increased. Expenses for healthcare, food and transportation are large, while the ability to generate income and grow crops is small.

The issue of youth unemployment is especially critical amongst HIV positive youths, with many lacking the opportunity or skills to generate income. The National Strategic Plan on HIV 2011-2015 (NSP) identifies capacity building for PLHIV in income generating activities and the provision of appropriate and adequate business start-up packs as key interventions to address this challenge.

### **Strategies including lessons learned and the proposed programme**

UNAIDS in collaboration with the National AIDS Secretariat and the Network of HIV Positives have considerable experience in empowering People living with HIV (PLHIV) through the provision of livelihood opportunities for PLHIV. Such experience and lessons learnt over the past 12 months will be critical for the implementation of this project.

Also UNIDO have a wealth of experience in supporting employment opportunities for young people; there is a bilateral understanding with UNIDO to link young people living with HIV to UNIDO's Growth Centres located in 5 Districts in Sierra Leone.

### Management and coordination arrangements

The project will be managed under the overall coordinating responsibility of the UNAIDS Country Office (UCO) in close collaboration with the National AIDS Secretariat, the Network of HIV Positives in Sierra Leone and UNIDO. Both the development and implementation of the project will be conducted by UNAIDS with support from the Joint UN Team on AIDS. Regular consultations will be organized by UNAIDS in collaboration with the National AIDS Secretariat and the Joint UN Team on AIDS.

### Fund management arrangements

UNAIDS will receive the resources and will manage the disbursement to the implementing partners including the Network of HIV Positives and/or the service providers in the UNIDO Growth centres. UNAIDS will manage the project in accordance with the signed MOU of the SL-MPTF.

### Monitoring, evaluation and reporting

UNAIDS will directly be responsible for the monitoring and oversight of project activities. The UNAIDS Country Office will give feedback, updates and progress in implementation during Joint Team meetings and regular reporting. UNAIDS will provide interim, progress in implementation and project completion report including financial reports. The UCO will compile the report and fit it into the appropriate reporting format of the MPTF Office.
