#### I. PURPOSE

## **Project Summary:**

The M&E unit was designed to enhance the LRF monitoring mechanism by incorporating the below activities into a more coherent and efficient framework and by expanding overall oversight management. The M&E unit aims at enhancing the efficiency, preventing unnecessary expenditures and avoiding project delays. This framework will consist of:

- 1. An increased frequency of field trips and monitoring meetings;
- 2. Closer and more technical follow ups on project implementation and financial activities:
- 3. A continuous evaluation and objective re-assessment of project achievements against pre-set targets;
- 4. A support system to meet timely completion with the objective of raising the effectiveness of projects and ensure cost-efficiency in their implementation, and
- 5. A support system to examine the final evaluation of the projects implemented under the LRF.

Effective oversight management of the LRF projects is time-enhancing and cost-efficient to both donors and beneficiaries. And since the M&E team will oversee all aspects of the project activities.

Project Managers are supported in achieving their pre-set deadlines in a timely manner. This will be advantageous to the benefactors since it will prevent the postponement of the project's activities.

Furthermore, any revisions made in the outstanding projects-such as a no cost time extension, a budget reevaluation or change in scope is effectively assessed and evaluated by the M&E team and hence, improving the cost-efficiency and decision making outcomes of those projects by the PAG team and LRF committee.

## **Project Objectives:**

The development goal of the M&E Team is to generate a framework whereby the operation and delivery of current and prospective projects approved under the LRF are able to improve efficiency, recognize and prevent unnecessary expenditures and project delays that may arise over the present time frame of each individual project.

The immediate objective of establishing an M&E Team is to strengthen the existing LRF monitoring mechanism by improving the timeliness, cost efficiency and reliability of the current LRF project activities.

#### **Project Outputs:**

- 1. Support Project Managers in achieving their pre-set deadlines in a timely manner, thus working in favor of the beneficiaries of each project, and
- 2. Revisions made in the outstanding projects such as a no cost time extension, a budget re-evaluation or change in scope will be effectively assessed and evaluated by the M&E team. This will improve all decision making outcomes and will ensure compliance with the above revisions.

#### III. RESULTS

## **Progress in Project Implementation:**

(Narrative description of activities planned to be implemented during reporting period and the progress of these activities)

## Reporting

Progress reports on progress achieved by the on-going LRF projects during the second quarter of 2011 have been received and reviewed by the M&E Unit.

Coordination with the program/project managers on improving the reporting quality as per the MDTF instructions has been actively set up.

Annual reports of 2010 have been all reviewed, edited and uploaded to the MDTF website for consolidation.

## Extension requests

In collaboration with the Ministry of Economy and Trade, the Prime Minister's Office, the Ministry of Finance and the UNRCO, the M&E unit co-supported during the second quarter the review process for five no-cost time extension requests for the following projects:

- a- LRF 14 Forest Fires Management Forest Fires Prevention, Forest Fires Fighting (Control) and Damaged Forests Assessment and Rehabilitation
- b- LRF 17 Flood Risks Prevention and Management in Baalbeck Hermel
- c- LRF 23 Hydro Agricultural Development for Marjeyoun Area
- d- LRF 24 Early Recovery of Nahr el Bared Surrounding Lebanese Communities Affected by 2006 and 2007 Conflicts
- e- LRF 22 Supporting Local Socio-Economic Development in War-Affected Areas of South Lebanon (Phase II)

#### **PAG Meeting**

A PAG meeting has been organized on April 4<sup>th</sup>, chaired by H.E. Minister Safadi to discuss the progress achieved by the LRF projects, the no-cost extension requests, the LRF future outlooks and the LRF documentary production. Recommendations were as follows:

# Next steps in resources mobilization:

The UNRC Office expressed that the LRF's future objective should focus on mobilizing more resources and expanding projects to cover further development areas and needs. The legal steps to follow in order to carry out such an expansion were questioned; to which the response was that this expansion had already been approved by the steering committee and that no other formalities were required.

The UNRC offered to support the resource mobilization process at this stage especially that







he is currently meeting with a lot of embassies to introduce himself as the new RC and he would bring in LRF and its mobilization efforts. The LRF Chair welcomed the idea especially that no serious progress has been done following the donors' conference held in September 2010. The chair recommended that the team from the ministries, prime minister's office and UNRCO cooperates to contact potential donors (embassies). Then, after short-listing the potential donors higher-level Minister-Ambassador meetings would be scheduled before technical staff meetings are held. In this respect, it was mentioned that some of the embassies were already met.

## **Extension Requests:**

LRF 14, Forest Fire Management project has been granted an extension of 3 month duration to achieve the pending activities.

LRF 24, NBC Lebanese Surrounding project was subject to different decisions based on components:

- Olive harvesters and associated farmers' training, olive solid waste and women cooperatives related activities are approved to be completed.
- The greenhouses, waste water treatment and slaughter house activities are to be evaluated by appropriate external evaluators which will be selected by the Project Approval Group. Expenses will be charged to each project. The PAG's decisions will be based upon the outcome of these evaluations.
- The micro-loans component is to be terminated.

## LRF 17 - Flood Risk Prevention & Management in Baalbeck-Hermel (Phase II)

- The main concerns of the PAG members are whether the implementing party is the right party to carry out the project and whether the planning and design of the project are efficient and realistic.
- An external evaluation was therefore requested to assess the methodology, design, future work plan, achieved results and impacts. The external evaluator is to be selected by the Project Approval Group. Expenses will be charged to the project's budget. The decision for approving the project extension request will be based on the outcome of the evaluation.

# LRF 23 - Hydro Agricultural Development for Marjeyoun Area

- The main concerns of the PAG members are whether the implementing party has the capacity to carry out the project and whether the planning and design of the project are efficient and realistic.
- An external evaluation was therefore requested to assess the methodology, design, future work plan, achieved results and impacts. This external evaluator is to be selected by the Project Approval Group. Expenses will be charged to the project's budget. The decision for approving the project extension request will be based on the outcome of the evaluation.







### **LRF Video Documentary**

The aim of the video is to portray the LRF's achievements as well as its future outlook. The 5 min film should therefore be presented in the form of a documentary that will help depict the various programs under LRF highlighting their achievements and showing the benefits to all sectors of the economy.

The final selection of the consultant is completed and Mr. Antoine Baaklini was selected. The selection was based on the consultant's qualifications, experience and budget. The Ministry's Media Office will work closely with Mr. Baaklini in order to attain the best results.

The video crew completed ten shooting days tackling the majority of the LRF achievements in the targeted sectors. Interviews with direct beneficiaries and local authorities as well as the program/project managers have been completed and will be reflected in the documentary. Close coordination with the MoET's Media Office on the final version and all related aspects of the video production has been set up and follow up is being performed by the M&E Team.

#### **LRF** Website and Newsletters

Joint efforts between the M&E unit and the Information unit at the RCO lead to the set up of an action plan to design and develop new LRF webpage and newsletter. The Newsletters shall be published on quarterly basis and will include a brief note on the on-going LRF projects, major achievements and impacts, in addition to photos from the field and a summary of the up-coming LRF events. The webpage's layout shall be modified in an attractive way to reflect achievements done by the closed projects, the on-going ones and the future outlooks. It shall include as well a specific section for the up-coming events and parts from the LRF documentary in addition to a detailed matrix of the 25 LRF projects and their relevant data and links.

## LRF Events

FAO has celebrated the closure of the LRF 14, Forest Fire Management Project, on May 23<sup>rd</sup>, in Bentael-Jbeil. The project started in Nov 2008 and was closed in May 2011. The ceremony included a number of speeches delivered by the project coordinator and the head of the implementing NGO summarizing the major achievements of the project in terms of equipment delivery, capacity building and reforestation activities.
