I. PURPOSE







Project Summary

The M&E unit was designed to enhance the LRF monitoring mechanism by incorporating the below activities into a more coherent and efficient framework and by expanding overall oversight management. The M&E unit aims at enhancing the efficiency, preventing unnecessary expenditures and avoiding project delays. This framework will consist of:

- 1. An increased frequency of field trips and monitoring meetings;
- 2. Closer and more technical follow ups on project implementation and financial activities;
- 3. A continuous evaluation and objective re-assessment of project achievements against preset targets;
- 4. A support system to meet timely completion with the objective of raising the effectiveness of projects and ensure cost-efficiency in their implementation, and
- 5. A support system to examine the final evaluation of the projects implemented under the LRF.

Effective oversight management of the LRF projects is time-enhancing and cost-efficient to both donors and beneficiaries. And since the M&E team will oversee all aspects of the project activities, Project Managers are supported in achieving their pre-set deadlines in a timely manner. This will be advantageous to the benefactors since it will prevent the postponement of the project's activities. Furthermore, any revisions made in the outstanding projects-such as a no cost time extension, a budget reevaluation or change in scope is effectively assessed and evaluated by the M&E team and hence, improving the cost-efficiency and decision making outcomes of those projects by the PAG team and LRF committee.

Project Objectives

The development goal of the M&E Team is to generate a framework whereby the operation and delivery of current and prospective projects approved under the LRF are able to improve efficiency, recognize and prevent unnecessary expenditures and project delays that may arise over the present time frame of each individual project.

The immediate objective of establishing an M&E Team is to strengthen the existing LRF monitoring mechanism by improving the timeliness, cost efficiency and reliability of the current LRF project activities.

Project Outputs

Main outputs include:

- 1. Support Project Managers in achieving their pre-set deadlines in a timely manner, thus working in favor of the beneficiaries of each project, and
- 2. Revisions made in the outstanding projects such as a no cost time extension, a budget reevaluation or change in scope - will be effectively assessed and evaluated by the M&E team. This will improve all decision making outcomes and will ensure compliance with the above revisions.

III. RESULTS

Progress in Project Implementation

(Narrative description of activities planned to be implemented during reporting period and the progress of these activities)

Reporting

Progress reports on the results achieved by the on-going LRF projects during the third quarter of 2011 have been received and reviewed by the M&E Unit.

Coordination with the program/project managers on improving the reporting quality as per the MPTF instructions has been actively set up.

Completion reports of the operationally closed LRF projects were received, reviewed and edited by the M&E Unit. Close coordination with the concerned UN agencies in this regard is being undertaken. The completion reports are expected to be posted on the MPTF website by the end of November.







LRF National Steering Committee - Recommendations

The LRF Steering Committee was held on August 9th at the Ministry of Economy and Trade. Major discussion topics tackled the overview of the progress made by the LRF projects, the extension requests, the LRF future outlook and the final recommendations made by the SC Members. Details are in the attached minutes in Annex I.

A balance of US\$ 2 M is currently available in the LRF. The SC agreed to open the door for new project proposals with emphasis made on socio-economic development and environmental issues. The RCO is to communicate the call for proposal for the eligible UN agencies. In this regard, a document summarizing all the requirement documentation and data for the new proposals was drafted and revised by the PAG Members and made available to the eligible UN agencies.

The SC approved the extensions requested by the LRF 17, 23 and 24 with few comments and recommendations on each of the mentioned projects. (Please refer to minutes for details). The M&E unit is to conduct close follow up with the concerned UN agencies on monthly basis to evaluate the progress made by the project and monitor the field activities to meet the projects' initial objectives. A monthly report is to be requested from the concerned UN agencies addressing the progress made in line with a detailed work plan with time frame for each of the project's activities. The M&E unit is to conduct sites visits periodically to assess the results.

The SC agreed on developing a summarized document for resources mobilization by the PAG Members and to set up an action plan to approach the potential donors with focus on the socio-economic development approach and the environmental priorities.

LRF Video Documentary

The aim of the video is to portray the LRF's achievements as well as its future outlook. The 12 min film as well as the 53 seconds spot have been finalized and reviewed by the PAG Members who had few adjustments that will be implemented by the production Director.

A new round of video shooting sessions will be undertaken with the General Directors of the Ministries of Agriculture, Industry and Social Affairs, to be included in the final version of the documentary with the aim reflect the government role in the whole concept.

The video will be used as a tool for resources mobilization for a second phase of the LRF.

LRF Website and Newsletters

Joint efforts between the M&E unit and the Information unit at the RCO lead to the production of the first issue of the LRF newsletter and an updated LRF webpage. The newsletter included success stories from different LRF projects, in addition to the major events, a summary of the LRF progress and financial status as well as pictures from the field.

The webpage's layout has been modified in an attractive way to reflect achievements done by the closed projects, the on-going ones and the future outlooks. It was designed to include specific sections for the up-coming events and parts from the LRF documentary in addition to a detailed matrix of the 25 LRF projects and their relevant data and links.

LRF Events

FAO conducted two events in North and West Beqaa for distributing milk collection stainless steel







jars to the farmers in the area, in a preliminary step to support the dairy sector in Lebanon in collaboration with the Ministry of Agriculture. In fact, FAO succeeded in establishing new farmers' cooperatives and initiating public private partnerships with the local private milk industry in a step to support the milk farmers' in the potential areas. This strategy is being adopted by the Ministry of Agriculture and is pushing to disseminate the lessons learnt through the project into other areas of Lebanon.

UNFPA conducted an event to honor 130 women beneficiaries from the LRF 12 microloans component. The beneficiaries were able to initiate small and medium enterprises in their home town and generate fixed incomes to support their families. This event came as a practical evaluation exercise of the impact made by the project on the socio-economic situation in the targeted areas.

Proposed Agenda

1. Welcome Note by H.E. Minister Nicolas Nahas

The LRF chair welcomed the steering committee members present at the meeting and launched the meeting with emphasis on how to proceed with the Lebanon Recovery Fund forward.

2. Overview of LRF Governance Structure and Status by UN Resident Coordinator's Office The UNRC Office presented an overview of the LRF status, governance structure adopted, financial progress and projects highlights:

- ➤ Out of the 25 LRF projects approved to-date by the LRF Steering Committee, 16 projects have been completed, 5 are ongoing and 3 are requesting no-cost time extensions and 1 project terminated
- ➤ All LRF reporting as of March 2011 is completed
- ➤ 2,098,481 USD are available for programming including the \$797,830 returned from participating U.N. organizations
- The LRF websites are updated and online (www.un.org.lb & www.mdtf.undp.org)

Following the recommendation of UNRCO; the SC members decided to make the Project Approval Group represented by the relevant technical staff corresponding to the PAG members to undergo and coordinate the more technical work.

3. LRF Future Outlook

- Next steps in Resource Mobilization
 - The SC decided to keep the name and structure of the LRF as it is for the upcoming phase that is planned to be more focused on development to be titled LRF-phase 2







- The Resident Coordinator, Mr. Watkins recommended to separate between the LRF (recovery focus) and the LRF (development focus) to make a distinction between the two and to close all financial accounts and related matters
- The SC decided to go for the top down approach for the resources mobilization for the next phase of the LRF
- The LRF chair recommended to prepare a list of potential donors (past & new) as well strategically plan what to ask those donors and how
- The LRF chair also recommended to channel the new objectives as per the related donors' and to put clear objectives to be sought through the LRF
- The ambassador of Spain informed the SC that Spain's current funding focus is related to environment, energy and water projects and that there is possibility and interests to channel funds to the MDTF for the LRF upcoming phase
- The SC requested supporting facts, documents and audiovisual (LRF video, publications, achievements...) materials that could contribute to the request for funding in the phase 2 of the LRF

- Call for Proposals

The SC decided to channel the remaining 2m USD to the LRF phase 1 and initiate the call for proposals following the already set guidelines and open to all focus but with a priority to support SMEs (to go green) and Agro-industry, Forest Fires Management, Economic & Industrial Zones development

4. LRF Project Extension Requests and Evaluation Results by M&E Unit

▶ Preliminary extension approved for 2 months to complete the following tasks:

- Assessment of possible alternatives for the targeted area in cooperation between UNDP and the municipality of Bkarzala
- Evaluation of the financial situation of the municipality of Bkarzala to operate and maintain the facility
- Feasibility study and Environmental Impact Assessment (EIA) to assess the environmental and socio-economic aspects of the intervention.
