

**Amendment no. 1 to the
Memorandum of Understanding
between
Participating UN Organizations,
the United Nations Resident Coordinator and
the United Nations Development Programme
regarding the Operational Aspects of the Viet Nam One Plan Fund II**

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations"), under the leadership of the United Nations Resident Coordinator (hereinafter referred to as the "UN Resident Coordinator") have developed a Viet Nam One Plan Fund II starting on 20 June 2008 and ending on 31 December 2016 (hereinafter referred to as the "Fund"), as may be amended from time to time, as part of their respective development cooperation with the Government of Viet Nam, as more fully described in the revised Terms of Reference of the Fund dated 8 March 2012 (hereinafter referred to as the "TOR"), a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee") to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government for the implementation of the Fund;

WHEREAS, the Participating UN Organizations, under the leadership of the UN Resident Coordinator, have agreed that they should adopt a coordinated approach to collaboration with donors who wish to support the implementation of the Fund and have developed a TOR to use as the basis for mobilising resources for the Fund, and have further agreed that they should offer donors the opportunity to contribute to the Fund and receive reports on the Fund through a single channel; and

WHEREAS, the Participating UN Organizations have agreed to extend the Viet Nam One Plan Fund II until 31 December 2017.

The Memorandum of Understanding between the Participating UN Organizations and the United Nations Development Programme (acting as Administrative Agent of the Viet Nam One Plan Fund II) is therefore modified as follows:

Preamble:

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding (hereinafter referred to collectively as the "Participating UN Organizations"), under the leadership of the United Nations Resident Coordinator (hereinafter referred to as the "UN Resident Coordinator") have developed a Viet Nam One Plan Fund II starting on 20 June 2008 and ending on 31 December 2017 (hereinafter referred to as the "Fund"), as may be amended from time to time, as part of their respective development cooperation with the Government of Viet Nam, as more fully described in the revised Terms of Reference of the Fund dated 8 March 2012 (hereinafter referred to as the "TOR"), a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the "Steering Committee") to facilitate the effective and efficient collaboration between the Participating UN Organizations and the host Government for the implementation of the Fund;

All other terms and conditions of the Memorandum of Understanding remain unchanged.
