ACTIVITIES REPORTED:

Main Substantive Activities:

Several papers on Morocco's cultural heritage completed. A national charter on cultural heritage preservation in place. A national preservation strategy in place and an advocacy plan for its dissemination finalized. A document defining the role of various departments in relation to cultural heritage prepared. Multiple training activities conducted and a self-teaching 5 module web based tool is now available. Multiple support material prepared including a film and a web site on Morocco's cultural heritage (www.patrimoinedumaroc.com). A management system for Living Human Treasures developed and 4 regional consultation workshops on "live cultural heritage" completed. Construction of the women's artisan complex in Foug Zguid is ongoing. Assistance to six rural communes during the elaboration of their municipal development plans to insure the integration of the preservation of cultural Heritage. Arguments and awareness on the contribution of women and youth in achieving the MDGs have been developed. A study for the identification of the endangered know-how in handicrafts susceptible to generate income for the women and the young people has been carried out. Two evaluations aiming to inform on the degree of achievement of the joint program expected results conducted: Evaluation of the integration of the priorities to protect and promote the cultural heritage, gender and sustainable tourism in the PCD and Evaluation of income generating activities.

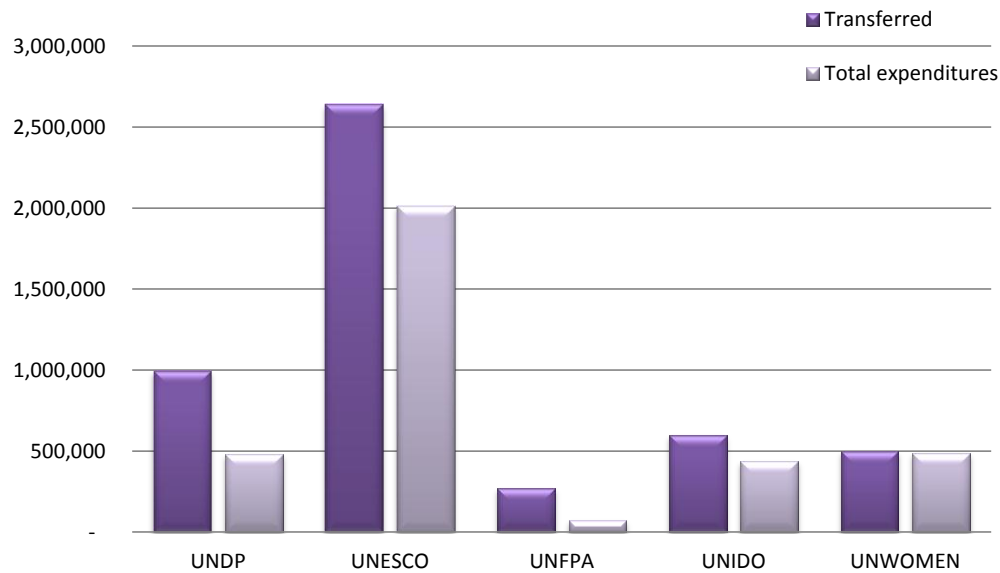
