

Amendment No. 1
to the Standard Administrative Arrangement
between
the Government of United Kingdom of Great Britain and Northern Ireland
represented by the Department for International Development (DFID)
and the United Nations Development Programme

United Nations Joint Programming on Gender Equality

The Government of United Kingdom of Great Britain and Northern Ireland represented by the Department of International Development (hereafter referred to as "the Donor") and the United Nations Development Programme (UNDP) acting as Administrative Agent of the United Nations **Joint Programming on Gender Equality** on behalf of itself and all the Participating UN Organizations, (hereafter referred to as "the Administrative Agent") have agreed as follows:

Whereas in Section I, Paragraph 1 of the Standard Administrative Arrangement signed between the Donor and the Administrative Agent (hereinafter referred to collectively as the "Participants") on 4 December 2009, the Donor committed itself to make a contribution of **Fourteen Million Nine Hundred Thousand Pounds Sterling [£ 14,900,000]** "and such further amounts as it may decide".

The Participants have now agreed to amend the Standard Administrative Arrangement. The Standard Administrative Arrangement between the Participants is therefore modified as follows:

Section I Paragraph 1: The donor decides to make a contribution of **GBP Twelve Million, Nine Hundred Twenty Seven Thousand, Six Hundred and Eleven Pounds Sterling [£12,927,611]** and such further amounts as it may decide (hereinafter referred to as the "Contribution") to support the Joint Programme.

Section I Paragraph 2: The Donor will deposit the Contribution by wire transfer, in accordance with the schedule of payments set out in ANNEX B to this Arrangement, in convertible currencies of unrestricted use, to the following account:

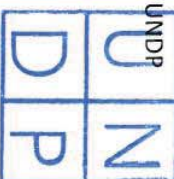
