# **Section II: JP Progress**

## 1 Narrative on progress, obstacles and contingency Measures

#### **Progress in outcomes**

General Progress of the joint programme:

Some programme's activities have concluded and others are still ongoing. The delivery rate has reached the 86% of the transferred budget and the main substantive result is the improvement in level of awareness, knowledge and participation of beneficiaries from different targeted groups.

#### Progress in outcomes:

Outcome 1:

The level of awareness and knowledge of beneficiaries from different targeted groups was improved through training activities in the field of:

- -Conflict resolution skills;
- -Local governance;
- -Citizenship;
- -Human rights;
- -Gender equity; and
- -Communication, mediation and negotiation skills.

At the front of developing and sustaining conflict resolution mechanisms in targeted communities, a convenors group was established in Tebbaneh-Jabal Mohsen area gathering key persons from different communities in Tripoli area.

#### Outcome 2:

The level of awareness and knowledge of beneficiaries from different targeted groups was improved in the field of local governance and socio-economic development through conducted training activities.

The level of participation of local communities in planning for socio-economic development was improved through participatory exercises of assessment and planning for the development of conflict sensitive socio-economic intervention.

The level of interaction between targeted communities and villages in Akkar area was improved through the participatory planning and decision making meetings, e.g. regional Working Group meetings, Participative Value chain Analysis, etc.

Output 1:

Reporting on results

Awareness has been raised at the local level about the role of the Lebanese Palestinian Dialogue Committee (LPDC). This improvement had positive influence on the



perception of Palestinian refugees in relation to the intention of Lebanese Government in improving the socio-economic situation of Palestinian refugees. Reporting on activities

The new strategy developed by LPDC during 2010 is being implemented through the MDG-F programme for the some of the activities. The newly recruited field officer is playing a key role in establishing links between the LPDC and the local community in Palestinian camps, municipalities and Popular Committees. There has been a further engagement of the LPDC in Nahr el Bared, including at the level of president.

#### Output 2:

Reporting on results

Forums in NBC/BC/Lebanese surrounding areas have not been established yet. A clear understanding of the type of interaction governing the Camps and surrounding municipalities has been established through detailed mapping and will serve the basis of initiating the forums.

A Conveners group for Jabal Mohsen-Tebbaneh / Tripoli was formed, following conflict/actor mapping and extensive preparatory consultations.

Involvement of the programme in supporting the Government of Lebanon in amending the labour law in order to ensure employability of Palestinian Refugees is still limited. The Government has yet to be formed and as a result the implementation decrees of the new labour law have not been issued.

#### Reporting on activities

The progress at the level of each targeted area is the following:

Tebbaneh - Jabal Mohsen area:

A group of key local leaders from the Tripoli area was convened with support from UNDP and the Common Space Initiative following initial preparatory phase of extensive conflict and actor mapping as well as local consultations. The group has since then gone through a process of conflict analysis, SWOT and peace assets to determine their strategy to address challenges in Tripoli.

Output 3:

Reporting on results

Awareness and knowledge of health care providers improved on general health and reproductive health topics.

Reporting on activities

Based on the findings of the gender-based needs assessment and the community recommendations during the dissemination meetings, the original work plan has been updated and tailored to meet community needs, priorities and expectations. Seminars targeting various healthcare providers (physicians, midwives and nurses) on health and reproductive health have been organized.

## Output 4:

Reporting on results

Working with a total of 2,283 students (991 Palestinians and 1,292 Lebanese) the programme has positively impacted the perception and level of knowledge of students on peaceful conflict resolution and tolerance.

As per the narrative reports received from the implementing partners in Lebanese and UNRWA schools, qualitative changes in knowledge and behavior are being perceived among some students. In fact, a considerable number of targeted Lebanese students are becoming more socially interactive and capable of building new relationships with others, working in groups and connecting with each other having fewer preconceived ideas. Even the most rigid young boys, who had stereotypical ideas about different communities, are now more tolerant of their peers from other areas.

This change in both perception and behavior was also perceived during the last riots that recently took place in Tripoli between two parties in conflict where a large number of the students refused to take part in the demonstration that they don't consider their own.

As for the Palestinian students, the persistent efforts of the trainers succeeded in helping them, students are finally opening up through sharing with the trainers their traumatic



experience during the Nahr el Bared conflict where the children had witnessed their families and friends being harmed in front of them. This is considered a breakthrough since it was hard for those children at the beginning to trust and voice their problems and fears.

Reporting on activities

- -Training targeting students and teachers is ongoing in 24 Lebanese and Palestinian primary and secondary schools. Twinning between secondary schools was established and exchange of visits between Lebanese and Palestinian students was conducted. The monitoring questionnaires were completed in the primary schools (public and UNRWA) at the end of the scholastic year with the data being compiled and analysed during the month of June 2011.
- -Capacity building on leadership skills, targeting youth groups and capacity building on Youth Friendly Approach targeting CBOs and NGOs working with youth were designed and implementing partners have been selected.
- -A training workshop on communication and interpersonal skills, peer to peer approach, advocacy skills, as well as HIV/AIDS prevention targeting 12 youth peer educators belonging to local NGOs and Palestinian camps has been organized. A movie was screened and participants were trained to facilitate awareness sessions on Gender Based Violence with their peers using the movie as an interactive tool.
- -Under the framework of Earth Day, environmental activities took place in the UNRWA schools where students planted trees and benefited from educational and fun activities for a day.

#### Output 5:

Reporting on results

Trust between members of Camps' Popular Committees (PCs) and Lebanese Communities has improved after the implementation of training sessions that provided PCs with skills that help them engage in positive dialogue with representatives of Lebanese communities.

The trust between Popular Committees and UNRWA has been improved since they considered the capacity building activity a valuable service that was provided by the agency.

Through the training, the PCs were encouraged to promote participation of women and youth in their work. As a result, women and youth groups will participate in the design and implementation of community development projects.

Reporting on activities

Training for the PCs was completed during the last reporting period. However, the PCs contacted the Programme for further training and were given a session on mediation in collaboration with University of Saint Joseph during this period.

Output 6:

Reporting on results

The UN has worked to develop a partnership with the Ministry of Labour to support the implementation of the amendments to the Labour Law which was adopted in August 2010 by the Parliament. The provision of support to the Ministry has been delayed following the collapse of the Government in January 2011. The UN is planning to reengage the new Minister of Labour following the formation of the new Government.

Reporting on activity and results

The activity associated with this output has been delayed due to the governmental situation.

Reporting on results

Awareness of participants from newly elected municipalities increased on topics related to municipal work and local governance.

Reporting on activities



Training targeting newly elected municipal officials in the 33 municipalities in Akkar on local governance was conducted within the framework of a national initiative sponsored by the Ministry of Interior & Municipalities (following the May 2010 municipal elections).

#### Output 2:

Reporting on results

Level of awareness on local socio-economic development participants in training sessions improved and participation of local communities in planning for development increased.

#### Reporting on activities

- -The training sessions on Local Socio-Economic Development were prepared in coordination with ESCWA, ILO and IMTI, and delivered to key stakeholders in Sahel, Middle and Higher Dreib clusters.
- -An extensive participatory process was undertaken to develop and finalize two strategic plans one for the vegetable sector in Sahel and one for the Olive sector in Dreib (Participatory Value Chain Analysis in Dreib and Participatory Rapid Appraisal in Sahel implemented in parallel). As a result, two strategic plans were developed, one for the vegetable sector and another for the olive oil sector.
- -The process of establishing the two sectoral forums that will be implementing the agreed upon strategies has been initiated and the core groups have been formed.

### Output 3:

Reporting on results

Capacity of one Microfinance institution was built through the implementation of a training program that targeted its staff members.

Reporting on activities

- -Two specialized training sessions for microfinance practitioners were organized.
- -ToT on Get Ahead for Business Management targeting women conducted.
- -A training manual on microfinance was prepared.
- -Two staff members from the local Microfinance institution Al-Majmoua are now certified ILO trainers.

### Measures taken for the sustainability of the joint programme

Measures taken for the sustainability of the joint programme:

- -The programme is focusing on building the capacities of professionals in the education system (teachers, directors, etc) in order to create a greater sustainable impact in the field of peace building through education.
- -Capacity building of local institutions (NGOs/CBOs/Municipalities/Popular Committees/women committees) will lead to sustainable results since the knowledge transfer is targeting representative and functional entities in targeted communities.
- -Local institutions that could host youth initiatives after the closing of the programme are being identified.

#### External to the Joint Programme

- Cause associated to programme design: some activities lead to fears and uncertainties in some targeted communities (mainly Palestinian refugees)

#### Briefly describe the current difficulties the Joint Programme is facing

- -The complicated socio-economic and political context of Tebbaneh Jabal Mohsen area led UNDP to work following a low profile methodology. This caused a limited exchange of information among participant agencies on this specific area.
- -The NBC/BC Forum has not been established due to the difficulty in recruiting a field officer to work in the region.

#### Briefly describe the current external difficulties that delay implementation

- -The tense political and security situation at the national level remains the major risk facing programme implementation. Many activities encountered severe delays due to the violence in Jabal Mohsen Beb el Tebbaneh area. Events in Syria are also causing uncertainty in Akkar and stakeholders often cancel meetings and workshops following developments in Syria and Tripoli. The situation remains tense and possible delays have to be factored into planning. In addition, the announcement of the UN Special Tribunal for Lebanon indictment is now imminent and may further deteriorate the situation. In fact, a number of capacity-building sessions targeting youth and NGOs were scheduled to start in June but have been postponed due to the clashes between Bab el Tebbaneh and Jabal Mohsen.
- -The cabinet resignation in January 2011 and the five months stalemate in the formation of the new cabinet delayed activities related to outcome 1, outputs 2&6 (labour rights law and its respective implementation decree)
- -Cultural context continues to be the reason of limited participation of young girls in some youth activities in NBC and surrounding villages especially those organized outside schools.
- -To avoid any misunderstanding with the Popular Committees, the selection of forum members is taking longer than anticipated.

### Explain the actions that are or will be taken to eliminate or mitigate the difficulties

The following actions were and will be considered to mitigate the internal and external difficulties:

- -The full revision targeting the joint work plan and the monitoring plan has mitigated most of problems related to the programme design.
- -Programme team is still putting efforts to invite parents of young girls to awareness and clarification meetings to achieve the gender balance in non scholastic youth activities.
- -Intensive meetings with all stakeholders in the camp took place to clarify roles and responsibilities of the forums.
- -With the formation of a new government, the programme will seek to advocate with the new Minister of Labour to issue required decree to launch the implementation of new Labour Law. However, the programme team is discussing alternatives in case the governmental situation will not improve to replace the activities associated to outputs 2 and 6 related to Labour Law and employability of Palestinians by other achievable activities.

#### **Current situation**

The Government continues to be the main counterpart whether in the decision making process or in the implementation.

The Council for Development and Reconstruction remains the governmental partner at the NSC level.

The Reconstruction and Recovery Cell (Prime Minister Office) is playing critical role at the PMC level and providing the governmental approach to participant agencies.

The Lebanese Palestinian Dialogue Committee is one of the main governmental counterparts considered a beneficiary and partner at the same time. The change in government could lead to a change at the level of President since this position is a political assignment.

The involvement of Ministry of Education at the implementation and monitoring levels is still efficient. The Ministry's focal point is still providing support to facilitate the implementation, reporting periodically to the Director General, and playing critical role in providing the holistic view about the situation in targeted schools.

The Municipalities and civil society organizations are more involved at the local level in targeted areas where regional working groups were established. In addition to the involvement in decision making and monitoring at the local and technical levels, the civil society organizations are assigned by some participant UN agencies as implementing partners in regard to subjects like conducting surveys, training of students and youth, etc.

Based on the success of the training activity in output 5, the Issam Fares Institute of the American University of Beirut (AUB) will replicate this activity in 3 additional Palestinian Camps. Also this success was evidenced by the PLO's General Secretariat leading to announce a restructuring and development plan that targets other Popular Committees in Lebanon hence up-scaling the training initiative.

The Communication and Advocacy Plan aims at simplifying this task and defining specific outputs and activities to be achieved within the programme's timeframe.

This plan includes some activities that are part of the Joint Work Plan. Other activities are part of wider initiatives that have been identified and partnered with the programme. Financial resources that cover the implementation of the communication and advocacy activities are deducted from the coordination budget and some activities involve participating agencies' funds.

The main target group of this Communication and Advocacy plan is youth from different Lebanese and Palestinian communities in North Lebanon. Additionally, the plan focuses on other local and national target groups like journalists, education professionals, and newspapers as main advocacy agents for peace in the country.

The main messages of the Communication and Advocacy Plan are: 1) Highlight the link between Development and Peace; 2) Promote the idea of Education for Peace; 3) Highlight the important role of women and youth in achieving Development and Peace; and 4) The importance of stable and successful Lebanese-Palestinian based on human rights approach.

Through the Communication and Advocacy plan, the programme will ensure linkages with UN and non-UN national initiatives tackling the same messages and beneficiaries. In this framework, the United Nations Information Centre (UNIC) and the UNDP-MDG Framework Project have collaborated.

- -Youth Dialogue Clubs: The peace building education approach is adopted by the JP through focusing on school students and non-curricular activities to build culture of peace and improve conflict resolution skills. This helps in improving the perceptions of members of dialogue clubs and reduces the level of tension caused by the prejudgment.
- -Youth Groups: gathering youth from different communities is providing participants new exposure and experiences. This is leading to change in perceptions and young men and women are expressing change in their understanding for the conflict in their areas.
