#### **ACTIVITIES REPORTED:**

#### Main Substantive Activities:

244 youth finished entrepreneurial training (of which 139 were female). 523 youth (319 are female) receiving entrepreneurial training. National Decent Employment Plan (2012-16) finalized. Migrant rights information campaign ongoing. 2,206 youth received vocational training. 4823 youth received social skills training. 1,009 youth informed about labor rights. National Youth Employment Plan drafted and pending approval. 20 community youth leaders received leadership training. Ten roundtables on youth employment formed, and the 11<sup>th</sup> municipal roundtable in Managua has been established in the National Youth Employment Commission. 3 agreements written (2 in Jinotega and 1 in Altagracia) for the employment insertion of young men and women. Migrant rights campaign designed.

#### Problems and lessons learned

- The Program design did not consider municipalities' geographical dispersion and Nicaraguan law in relation to credit access for people under 21 years old. This issue hampered the economic development strategy stated in the Program which seeks to promote faster access to credit and facilitate the establishment of production chains at the municipal level.
- The training process, employability and job placement was carried out without considering academic level of the target groups and local demand and supply, affecting the effectiveness' of the training and retention ratio.
- Although the Program planning and implementation was a joint process and in accordance to the Government's priorities, some weaknesses were found in the counterparts institutional capacities in order to respond to technical and financial commitments, this due to the limited staff number (overload capacities) and lack of expertise on credit, fund management and business plan development.


