EXECUTIVE SUMMARY

I. Purpose

The event for Introducing the UN Global Compact was held in Sedona Hotel on May 1, 2012. The overall objective was to promote responsible business in Myanmar, in particular supporting inclusive job creation and sustainable development. It was also organize to coincide with the visit to Myanmar of Mr. Ban Ki-Moon, UN Secretary General. In light of recent developments in Myanmar, there is an expectation that the country will become increasingly integrated into the global economy moving forward.

II. Assessment of Programme Results

i) Narrative reporting on results:

The event brought together national and multinational companies together will be a critical step to embedding universal values and responsible practices into the private sector in Myanmar. In this context, the Office of Resident & Humanitarian Coordinator and the Peace building Support Office, and the UN Global Compact Office organized the event.

The meeting consists of a high-level session attended by Mr. Ban Ki-Moon and other high level officials, followed by a series of working-level roundtable discussions. The aim was to:

- > Introduce and build a common understanding of responsible business practice and shared value in the context of Myanmar;
- Examine how the private sector can contribute to sustainable development;
- Recognize new Global Compact signatories in Myanmar:
- > Promote responsible investment opportunities and job creation; and
- > Create linkages between Myanmar and the international business community.

The discussion also introduced the UN Global Compact in Myanmar with the hope of making a contribution to advancing responsible business and sustainable development. Fifteen local companies officially submitted their applications to the UN Global compact.
