1. The ongoing technical work for the rehabilitation of Sa'ada women's building will contribute to peace building by providing safe and protective environment for women to restore their livelihoods by providing: adult literacy and livelihood skills training.

2. The information from the two completed market assessments is now available to inform job placement and ensure that our livelihood interventions are feasibile and sustainable to strengthen resilience.

Reasons for low achievement and rectifying measures

(1) Late arrival of funds, which has delayed the recruitment of project staff and hence the start up of activities. This challenge has been addressed through assigning the agencies available staff with additional tasks, as well utilizing UN field offices and staff to the extent possible.

(2) Lack of clarity of roles and responsibilities among UN agencies (due to staff turn over following planning). This challenge has been addressed through good cooperation between agencies and team work to achieve the project goals.

(3) Security. Volitility has delayed some activities, such as the Training Of Trainers for business skills. This challenge has been mitigated by changing the training venue from Yemen to Egypt.

(4) Lack of security and instability, as a result of the ongoing conflict in Hadramaut between the Government of Yemen and Al-Qaeda in the Arabian Peninsula (AQAP) has threatened to the smooth implementation of project activities. The deterioration of the security situation and the control of large areas in Hadramaut by AQAP will restrict the access of partners to target beneficiaries. In response, IOM aims to recruit and work with local staff in Hadramaut. Their local knowledge and strong links with communities will ensure improved access to target areas and facilitate operation activities.
