Project Summary	<p>This project will have two faces, the ALP and the ECCD, the project will 1) recruit and train 60 ECD teachers and 40 ALP teachers on effective child friendly pedagogical approach as well as Psycho-social skill. 2) pay incentives to the 100 (60 ECD, 40ALP) teachers to boost their morale in teaching. 3) construct learning space, 20 TLS (10 for ALP, 10 for ECD), 4) supply reading and play materials, 5) train PTA/SMC on resource mobilization and effective governing skills , 6) conduct campaigns on go to school initiative, 7) network with BBC media action and GESS to form listening groups to discuss the benefit of Girls education and how to reduce impediment to girls education, and 8) integrate Lifesaving messages on HIV/AIDS, GBV and child protection in education campaign and peace building. The project will target 5,000 direct beneficiaries; this will include returnee from exiles and internal displacement, enrolled demobilised child soldiers who fought alongside SSDM Cabra faction, young mothers who missed out the opportunity to go to school due to early marriage, however the community mobilization will cover the entire public because ADCORD will form Listening group in each payam.</p>

BACKGROUND INFORMATION						
1. Humanitarian context analysis.. Humanitarian context: Describe the current humanitarian situation in the specific locations where this project will be implemented	<p>The war that broke out on 15 December 2013 has a very devastating effect on the already ill equipped educational infrastructures, as a result of the destruction of learning materials and facilities, lives were lost and children were driven out where there are no existing schools, due to persistent political fragility such as cattle raiding, crisis between SSDM cobra faction and Government in greater Pibor and the Current crisis that started on 15 December 2013, the education situation in Pochalla and Pibor were already at risk, many children missed out going to school at the right age, and many school going age children were trapped into vicious circle of conflict, all these require a holistic approach of education intervention such as ALP to cater for the need of over aged children, and ECD to cater for the need of displaced children below the age of 6, according to the assessment conducted by ADCORD, to-date Pochalla is having a total population of 60,000 but with only 12 poorly equipped schools, no ALP center and no ECD centre as well, Pibor is having one functional primary school and one ALP centre while there is no ECD centre as well, therefore opening ALP programme will provide opportunity for the youth who missed out the opportunity to go to school to finish the primary circle in a flexible way and secondly life saving message like HIV/AIDS can easily be passed through the ALP, to bridge this service gap ADCORD will open 10 ECD centers, 5 in Pibor and 5 in Pochalla, ADCORD will also open 10 ALP centres 5 in Pochalla and 5 in Pibor to cater for over aged children who missed out the opportunity to go to school at the right age.</p>

Indicates references to assessments such as Multi-cluster/sector Initial Rapid Assessments (MIRA)	<p>The project area was identified after thorough assessment conducted both by inter cluster joint assessment and ADCORD, in both cases a quick observation found out that the current population in pibor central is about 48,264 but with only one functional primary school and one ALP centre, there is no ECCD centre to take care of the children below the age of 6, likewise pochalla has a total population of 72,340 but having 12 ill equipped primary schools, there is no ECCD centre and no ALP centre, this scenario put the entire generation in pochalla and Pibor at risk of losing their future if not rescue in time therefore ADCORD in consultation with local education authority agreed that ALP will be ideal for this disadvantaged youth and ECCD will provide solid foundation for the young generation to start their future well.</p>					
3. Description Of Beneficiaries	<p>This project will benefit people who have returned to greater Pibor after the end of crisis between SSDM cobra faction and the Government or those who persisted and endured through and stay during the conflict in their hide out, the direct beneficiary will include 500 demobilized child soldiers who missed out the opportunity to go to school at the right age as they were engaged in violent conflict, the project will also target about 500 young mothers who missed out the opportunity to either join or finish primary school cycle due to early marriage, other category of beneficiary will include at least 2000 children from the age of 6 years below to benefit from Early childhood development, Youth from the age of 12-18 who missed out the opportunity to go to school at the right age will as well benefit from the Accelerated Learning program so that they can finish their primary school cycle and generally but no limited to parents will benefit from knowledge about the importance of girl child education</p>					
4. Grant Request Justification.	<p>Building quality education sector is vital in life saving both to individual, local communities and to South Sudan as a whole, however it is a complex task requiring the development of human as much as physical capital and changes in some cultural attitudes and practices especially in regards to girls education. The education</p>					

need in greater Pibor and Pochalla counties are obvious and pressing, ranging from absence of learning infrastructures both for ECCD and ALP, lack of Teacher for the ECCD and ALP and lack of teaching and learning resources, therefore the grant request will be used for financing the construction of temporary learning space, training ECCD and ALP teachers on child friendly pedagogy and psycho-social skills, including life saving messages like HIV/AIDS prevention and integrating peace building in the ALP curriculum, basic hygiene informational and subject content, the funding will also be used to trained PTA oo school governance as this is vital for sustainability, finally part of the funding will support community mobilization activity as change of attitude toward girl child education is required in this geographical location. In considering how best to respond to the above needs, ADCORD is guided by variety of consideration, one is the Organization own criteria which includes where the needs is the greatest, where others are not working, and where the need is likely to be the greatest. The second is the views of the current potential beneficiary of ADCORD's activities. The third is priority of Government of South Sudan which currently includes teacher training, construction of learning space and Girls education.. The fourth is the interest of ADCORD to build local capacity and transparency in operation.

Currently there are no partner running ECCD in Pochalla and greater Pibor so ADCORD will be the only organization, undertaking this project however there is need for stronger and effective collaboration with the County education department in order to ensure sustainability, while Pibor has one ALP centre, ADCORD will select a payam with no ALP to ensure that there is no duplication, and Pachalla does not have any ALP centre as well

Justify Chosen Gender Marker Code	ADCORD will develop strong community mobilization strategy targeting female, First is formation of listening group in each payam where ADCORD will work in collaboration with BBC media action /GESS program to play recorded information about the importance of girl child education and this will stimulate discussion and guided debate on the importance of girls education to individual family, to the community and to the Nation. This listening group will meet once every week to listen and discuss how to remove community based and school based impediment to girls education. secondly ADCORD will recruit and train Girls mentors in each ALP center, the key responsibilities of girls mentors is to provide remedial support to girls incase they have any difficulties to cope up with learning programmes and even personal challenges, she will be a female staff who will share her success stories with other female pupils and regularly provide guidance to female pupils on coping mechanism. ADCORD will pay special attention to young mothers who missed out opportunity of attending regular primary education and are willing to join ALP, ADCORD will recruit the young mothers and provide them with relevant life skill program in addition to the regular program in school so that they appreciate the value of education in their life. ADCORD will provide dignity kit to the female youth in the ALP class, this special attention aimed at minimizing absenteeism and embarrassment that might arise from menstruation cycle that will help to put female at the same platform with male. Finally ADCORD will recruit more female teachers both for ECCD and ALP most specially targeting returnee girls who might have completed secondary schools from Ethiopia or Uganda, this category of secondary school leavers will be trained to teach in their community and act as role model for girls in their community
