Amendment No. 1 Memorandum of Understanding between Participating UN Organizations¹, and

the United Nations Development Programme regarding the Operational Aspects of the Malawi SDG Fund

WHEREAS, the Participating United Nations Organizations(hereinafter referred to collectively as the "Participating UN Organizations") signed this Memorandum of Understanding developed the SDG Acceleration Fund in Malawi (hereinafter referred to as the "Fund") starting on 1 December 2018 and ending on 31 December 2023² (hereinafter "End Date"), as may be amended from time to time, as part of their respective development cooperation with the Government of Malawi (hereinafter referred to as the "Host Government").

NOWTHEREOF, the Steering Committee, on 9 August 2022 approved the extension of the Fund from 31 December 2023 until 31 December 2027.

The Memorandum of Understanding between the Participating UN Organizations, the Resident Coordinator and the United Nations Development Programme (acting as Administrative Agent of the Malawi SDG Fund) is therefore modified as follows:
