Le suivi du portefeuille s'est poursuivi à travers les outils et les mécanismes de coordination mis en place. Ce sont entre autres 10 réunions, 03 missions de suivi, la participation à des activités des projets, le suivi de l'élaboration d'un nouveau projet. Les projets IRF 402 et 403 viennent de prendre fin après avoir bénéficié d'une extension sans coûts de six mois chacun. Globalement, sur six projets que compte le portefeuille, cinq projets prennent fin cette année à l'exception du projet transfrontalier avec le Burkina Faso où le plaidoyer est entrain de mener pour une extension avec coût pour répondre à des défis nouveaux. L'appui continu de coordination va permettre d'accompagner tout le processus d'extension de ce projet, les activités de clôture pour les autres projets et la finalisation ainsi que le lancement d'un nouveau projet borderland. Les évaluations externes de trois projets sont en cours. Les leçons apprises de ces projets seront capitalisées au sein du programme résilience nord-est mis en place par le SNUD et dans lequel les projets PBF jouent un rôle important.

Les projets PBF localisés dans la partie nord du pays contribuent efficacement aux réponses de l'Etat dans sa stratégie de renforcement de la résilience des communautés pour faire face à l'avancée de l'extrémisme violent. A ce titre, lors de la troisième réunion du Comité Directeur Conjoint du Cadre de Coopération pour le Développement Durable (CCDD) 2021- 2025 entre le Système des Nations Unies en Côte d'Ivoire et le Gouvernement, les réalisations du projet transfrontalier avec le Burkina Faso dans le renforcement des services sociaux de base et la gouvernance frontalière pour la prévention des conflits ont été appréciées au même titre que d'autres projets et programmes par l'ensemble des parties prenantes.

Il faut ajouter notre contribution et notre participation à la coordination technique interagences du programme résilience nord-est à laquelle participent dix agences. Notre rôle d'appui conseil et d'orientation contribue à rechercher des synergies entre les projets PBF et d'autres projets existants. L'opportunité d'une visite conjointe dont les préparatifs sont en cours nourriront cette stratégie.

En effet, les deux projets soutenus par le PBF ont renforcé le rôle de premier plan du Système des Nations Unies dans l'engagement des partenaires techniques et financiers sur la nécessité de recentrer l'attention et les investissements vers la résilience autour de la frontière nord de la Côte d'Ivoire.
