1.1 Overall project progress to date

The status of the project is on track. The preliminary preparatory activities have been completed including passing internal agency approval mechanisms for projects, doing due diligence by conducting micro-assessments establishing the operational budget programming and signing agreements of cooperation with implementing partners and conducted baseline evaluation Technical working group and project steering committee have been established to oversee the project and closely work with the implementing partner. The technical team meet on timely basis to delebarate on the project successes and identify challenges that may affect the smooth implementation of the project. Implementation of the project activities is smoothly going on in the ground with all components being rolled out and series of activities to increase youth political participation being held as per the project document. With respect to evaulation the baseline assessment was carried out at the beginning of the project to establish benchmarks. Preparations have already started for an end evaluation to be carried out subsequent to completing remaining project activities. In addition, since we are at the end of the project more impacts of the activities and capacity building are becoming more apparent for instance in the increase of youth included and participating in political postions.

Given the recent/current political/peacebuilding/ transition situation/ needs in the country, has the project been/does it continue to be **relevant** and well placed to address potential conflict factors/ sources of tensions/ risks to country's sustaining peace progress? Please illustrate. If project is still ongoing, are any adjustments required? (1500 character limit) The statebuilding process in Somalia is still ongoing in particular since Somalia is in the process of reestablishing legitimate State institutions and systems of governance at the Federal Member State and District level. Youth inclusion in political decision making remains critical as over two-thirds of Somalis are under the age of 35 and are currently under represented in Somalia's political processes. In light of this, the project continues to mobilize and capacitate youth networks and associations to take part in the ongoing state and peacebuilding process. In the context of South West State and Jubbaland, the project interventions is changing the attitudes of decision makers and their constituences in the locations which is fundamental to ensuring the meaningful inclusion of youth in governance mechanisms. It is worth noting also that Somalia is due to hold presidential elections in early 2021. The initiatives of the project are timely in creating the right atmosphere for maximum youth inclusion in the political process. The relevance of the project is very handy here as it addresses potential conflict factors and tension arrising from divisive elections.

Somalis are alos a clan based society where clan loyalty is always a priority at the center with a particular focus on young women and builds their capacity to engage more meaningfully and

substantively. The project tackles these social dynamics through intergenerational dialogues with youth and community elders.

The project facilitates the use of innovative communication platforms including social media (Facebook, Twitter, etc), radio podcasts, and web TV, to reach out to youth creating a channel for young women and men to express their visions for the future of Somalia. By amplifying young people's voices, the project promotes the exchange of ideas among peers and communities at large, challenging negative perceptions and fostering an intergenerational dialogue and trust. Equipping young women and men with the skills to express themselves through innovative communication tools, the project empowers them to actively engage in the debate and to voice their ideas, concerns and needs to society at large enabling the use of communication as a means to achieving the robust participation of young women and men in peacebuilding. These innovative platforms are tools that are already popular among the Somali youth allowing for a wider platform to be reached both regionally and nationally.

During the youth forums, the discussions were facilitated using Slido, a live polling application. Through the application we had over 2,500 engangements from the participants. This allowed us to gather statistics, and survey responses during the discussions. These included polls on issues that they found most pertinent to them, as well as take perception polls.

To support the voice of youth in the political debate on the key issues of the day, the project has facilitated 11 youth-led campaings across the three districts reaching over 2,975 youth. Through the use of innovative social media platforms, over 240,000 audiences reached on Facebook, Twitter and on Youtube amplifying voices of youth on political participation. A project website has also been set-up. Likewise, a total of 170 radio programmes has been aired in the three regions where relevant topics have been debated by prominent youth figures.

Two youth consultations have been held in Kismayo and Baidoa bringing together youth leaders and elders and detailed discussions made on youth participation and recommendations passed to stakeholders. 44 blogs have been produced by youth in the three regions and 22 short videos developed carrying youth voices on key political topics. District Youth Councils have been formed in the three regions to create a permanent mechanism for youth participation in local governments and a training on communication for impact held for youth networks in the three districts. A total of 166 young people participated in capacity building workshops in the three districts of Dolow, Kismayo and Baidoa.

In addition, governance experts and youth fellows have been placed in the Ministries of Youth and Sports to ensure youth priorities and voices are considered and included in policies, activities and planning.

Through a series of project interventions, youth in the three districts feel energised and empowered to speak on peace and state-building. Youth-led campaigns held in the three districts led to formation of youth associations to increase voices of young people to advocate for their rights. for example, Dolow, a rural town had very low youth movements and young people were disengaged from decion making processes and women had the rare opportunity to talk to and hear from senior government officials. But through the project activities, young people engaging with decision makers to facilitate youth participation become often.

Similarly, the radio programmes sponsored by the project is impacting the discourse on the ground with the elderly attitude to youth inclusion changing. In the blogs written by youth and videos developed, the youth are delving deep into issues they deem important for their future and are learning to put it across,27% young people elected in Parliamentary Jubbaland Elections,40% women out of the youth elected, this is directly attributed to the project intervention.

"Social media can facilitate peace by encouraging valuable dialogue between people from different ethnic, religious and political backgrounds. This dialogue can, in turn, alter attitudes, change perceptions, and encourage increased tolerance & mutual understanding between ethnic groups who would otherwise never have had the opportunity to engage with one another" Hasan Nur- Young Journalist.

The project experienced a delay due to the breakdown in relation between the Federal Government and Federal Members State. The suspension of this relationship has led to a request for a no-cost extension. The changes in the political dynamics and the appointment of new Ministers also contributed to project delays as the project team will need to stop implementation as the new Minister's are onboarded and go through the process of updating and obtaining approval from the Minister to continue project implementation. In some cases, the changes in Minister's had an adverse impact on the project implementation as they wanted to create substantive changes to the project document. There were also challenging in holding steering committee committees. The project team has worked through these challenges and as of now the project is going on well and slated to be complete by the end of the year.

<u>Outcome 1:</u> Young men and women can effectively participate in decision-making processes in Baidoa, Dollow and Kismayo district and South West and Jubbaland State levels by the end of the project.

Several activities took place to ensure the achievement of the outcome. This includes activity 1.1.1, in which 12 Youth fellows (40% women) have also been appointed (4 in each district) in the Ministries of Youth and Sports in Jubbaland and South West State. Their roles are to amplify youth voices in target campaigns. In South West State, the youth fellows, reviewed the current Youth Policy and made substantive inputs, including ways that the policies could pay more consideration to other youth in vulnerable situations including those with disabilities and those in prison. They also participated in the launch of the policy and raising awarenes around the policy with other youth. The youth fellows as per activity 1.3.1, will be further trained on governance in December in order to amplify their influence and future aspirations.

In activity 1.2.1, youth-led and youth organizations were identified and capacity assessments were conducted in prepartion for their capacity building. Subsequently, training manuals on youth leadership and organizational management has also been developed in consultation on youth leaders and local administrations. The training manual covers mediation, policy writing and financial management. Training workshop on peace building and conflct resolution was also be delivered to district council members and regional youth associations. The training was meant to building the capacity of young people to facilitate effective trainings to their peers continuously.

As per activity 1.3.2, three youth forums were organized in Baidoa and Dolow with the participation of 160 young people from youth associations to discuss: the effectiveness of youth associations, women's participation, the role of youth in constitutional review. The forums included mock debates on the importance of inlcusion of women and other vulnerable groups in political spaces. They also included discussions around the constitution where youth mdae substantive inputs into what can be added to specific articles in the consitution for it to be more inclusive of youth priorities. The position papers around this topics are in the drafting processes. The second round of forums will take place in December, the topics that will be

covered, include gender dynamics in urban spaces, identities in culture, arts and sports and social entreprunership. These topics were selected by the youth. Subsequently, position papers for the results from the discussions in the forums.

Outcome 2: Decisions taken by District authorities in Baidoa, Dollow and Kismayo district and South West and Jubbaland State are reflecting young men and women's priorities by the end of the project.

Numerous activites were carried out to ensure the above-mentioned outcome. As per activity 2.1.1 and 2.1.2, governance experts and youth councils were embeded to the Ministry of youth and sports and the Mayors office, respectively, Members of the youth council are competitively elected by the youth in the different wards that make up 4 Districts (Baidoa, Dollow, Kismayo and Afmadow). The youth councils have workplans and terms of references created jointly by them, the Mayor and UN-Habitat. 8 Governance experts are on board as part of the project; at the federal level there are 2, and in Baidoa, Dollow and Kismayo. A governance expert training on leadership, peacebuilding and governance was conducted for the 8 experts. Subsequently, the governance experts have been instrumental in ensuring the impact vis a vis the objectives of the project. Their main achievements include, assisting in ensuring political environments that are conducive to youth participation, organizing consultations and youth dialogues, advising Ministers on how upcoming policies can be more inclusive of youth.

As per activity 2.1.3 and 2.1.4, several discussions with the governmental stakeholders have been held to highlight the importance of youth inclusion. While majority of these stakeholders supported the idea of youth's political participation, the project allowed for practical strategies to be implemented by the government. For example, in Jubbaland the Ministry of Youth and Sports, through the project are in the process of drafting a yout policy in their State that operationalizes the National Youth Policy. In addition, South West State Ministry of Youth and Sports are creating a strategy through the project that will ensure more youth in parliament. Both States also held youth days to further emphasize their commitments to youth political participation.

As per activity 2.2.1, 240,000 youth have participapted with special focus on information sharing on youth political empowerment through the various social media channels, 170 radio programmes have been aired across the three districts with youth activists and important panel of individuals discussing tailored topics to spark youth political empowerement discourse among the population. 22 short videos have so far been developed in which young people are sharing their views on the ongoing peace and statebuilding process. Additionally, through eleven youth-led campaigns, 2975 youth have campaigned across the three districts on topics including peace, youth participation in ongoing political processes, calling on the federal government and state governments to find away to work together to preserve the gains made in peace and state building. Intergenerational dialogue between youth and community elders have been organized in project target areas. The aim of the dialogue was to understand how the democratic life and participation of young people can be enhanced through more robust mechanisms at the community level.
