PART 1: OVERALL PROJECT PROGRESS

Briefly outline the **status of the project** in terms of implementation cycle, including whether preliminary/preparatory activities have been completed (i.e. contracting of partners, staff recruitment, etc.) (1500-character limit):

Overall, the project delivery is progressing and on track despite the challenges due to the State of Emergency put in place by the Solomon Islands Government (SIG) as a result of the COVID-19 pandemic. This ultimately delayed the implementation during January to June 2020. Project activities resumed in July when restrictions were eased by SIG. There is strong commitment amongst partners to implement the 2020 annual workplan.

In particular, in the five target provinces, the project continued to support the provinces and communities through strengthening participation of youth and women in the consultations for the Traditional Governance and Customs Facilitation Bill, a desk review and gender analysis of the draft bill was undertaken to support inclusiveness; a review of targeted laws and policies to inform policy statement on the development of the by-laws took place. Additionally, the establishment of the Provincial Youth Councils; and capacity building trainings on peace building, anti-corruption and climate change linking to the natural resource management were conducted.

The project successfully reached 1208 beneficiaries (723 Males and 485 Females). A total of 626 people attended the provincial consultations on the Traditional Governance and Customs Facilitation Bill, 162 (89 males and 73 females) youth participated in revitalisation workshops for the Provincial Youth Councils; 364 (278 Male and 86 Female) participated in the Customary Land Act awareness and recording of six customary tribal lands, and 56 youth (17 Female and 39 Male) from Guadalcanal, Honiara, and Malaita Youth Councils participated in the trainings in Peacebuilding and Anti-corruption linking to Natural Resources Management workshops. These trainings will continue for youth in Western and Choiseul Provinces until end of November 2020.

The baseline study is progressing, and the report is anticipated to be complete at the end of November 2020. The restrictions related to COVID 19 pandemic put in place by the Solomon Islands government delayed data collections which resulted in the delay on the completion of the report.

In the next six months, the major activities anticipated are:

o Support to the office of the Prime Minister on the Constitutional Reform

- Completion of recording for the 6 customary land tribal groups (one in Western Province, one in Guadalcanal and four in Malaita Province).
- o Drafting of the policy statement and consultations to inform the development of by-laws for customary holding groups under the customary land records Act.
- Support for Youth with advocacy for inclusive decision making in natural resources.
- o Development of 5 years strategic Plan for the National Youth Congress.
- Technical support to Provincial Women's Caucuses to advocate at the provincial level on natural resource management and climate adaptation including Traditional Governance Bill recommendations advocacy.
- Community awareness on existing laws and policies that protect women and girls.
- Advocacy for the implementation and monitoring of existing laws and policies to protect women and girls from sexual exploitation and abuse.
- o Conduct of women's empowerment in leadership and decision-making trainings.
- Conflict analysis within target communities exploring sustainable natural resources. Develop alternatives to inform policy frameworks and capacity building plans.
- o Completion of the Anthropological Study

With the UN Sustainable Development Goals Agenda as a guiding thread, the Inclusive Governance of Natural Resources for greater social cohesion in the Solomon Islands (IGNR) project works to advance youth participation in both civic and political life, their economic empowerment and their role as peacebuilders.

The project organises women, including grassroots women, to have a say in the sustainable development of their communities. It does this by creating space and opportunity for women leaders from communities, churches, civil societies, government, provinces and private sectors to engage and dialogue on national policies that can have an impact on their lives.

The project has provided training in leadership and peacebuilding, with appropriate learning tools to women and youth. Consultations, workshops and the revitalization of Provincial Youth Councils have been the main avenues for young leaders and women leaders to collaborate and coordinate activities.

The revitalization of Provincial Youth Councils has vastly improved participation of young people in actively discussing issues affecting their lives and development at the provincial and community levels, and in seeking solutions.

Giftson Semi, youth activist and one of the participants of IGNR consultations for the Traditional Governance Bill and the revitalisation of the Western Provincial Youth Council notes that: "These consultations are essential in times of crisis when quick decisions need to be made. Such events help to hear the voices of young people and build an inclusive and strong country where everyone is part of the dialogue." https://www.pacific.undp.org/content/pacific/en/home/presscenter/articles/2020/supporting-todays-youth-is-the-best-way-to-build-a-sustaining-peace-in-the-future.html

Preparatory sessions on the Traditional Governance and Customs Facilitation Bill (TGCFB) were held for women and youth from Honiara and targeted provinces. These sessions were an opportunity for the women and youth to network, form alliances and discuss issues affecting them in the area of land and natural resource governance. In addition, the preparatory meetings equipped the women and youth leaders with the tools and information needed to understand the contents of the TGCFB, including the application of a gender lens. The women and youth were able to well articulate their issues. A consensus arose with consolidated recommendations for the Solomon Islands government on the TGCFB.

These recommendations have strongly reflected the women's and youth's voices. The bottom-up development approach is appreciated by both women and youth. They recognise the importance of their knowledge, representation and collective action as a powerful resource that can promote substantiable use of natural resources. Below are some statements made by women leaders from Auki, Malaita Province during the TGCFB consultations.

"The preparatory session really helps us the women to understand the bill"

"It is very important to promote our traditional and custom values and to understand that both men and women must participate equally in all decision making at all levels"

"We need both men and women to participate equally in all decision-making levels and therefore the need to strengthen and empower women about the Bill"

<u>Outcome 1:</u> The Government is equipped with analyses, laws, policies and frameworks on land and natural resource management which are inclusive and reflective of customary governance

Rate the current status of the outcome progress: On track

Progress summary: (3000-character limit)

Major consultations on the proposed TGCFB 2018 were completed successfully across five provinces (including Honiara) reaching 626 stakeholders. A total of 309 female and 317 males participated from national, provincial and community levels. Provincial government members, community leaders, women and youths provided recommendations towards the final draft bill. The journey to get women and youth voices heard has not been easy especially, on a public stage. There is a slow but increasing recognition of women's and youth lived experiences and their important and meaningful contributions in policy and legislative development processes including in traditional governance.

Langi Sunga, President of Western Provincial Youth Council, in his opening remarks during the TGCFB consultations for youth in Western Province mentioned;

"First of this kind in the country for provincial youths to be consulted on a national bill. Youths have been left out and this is a great opportunity for us to contribute to the bill and encourage us to work together to ensure our recommendations are include in the draft bill".

Nannette Panda, a member of the Western Province Women's Caucus and member of the Western Province Advisory Committee stated;

"...women from Western Province come from a matrilineal society, and we believe women are custodians of the land and therefore women's voices are crucial and must be heard at all levels, especially for the future generation".

In addition, the preparatory meetings equipped the women and youth leaders with the tools and information needed to understand the contents of the TGCFB, including the application of a gender lens. For instance, in pre-tests conducted during the preparatory sessions for youth, only 30% of youth knew about the Bill, 70% did not know about the Bill. Post-test showed that 95% of youth have an increased knowledge and level of understanding of the Bill after the preparatory sessions. An evaluation conducted for women participants from 3 provinces clearly showed that the bill was relevant to them and that they are satisfied with the content analysis of the bill.

The Social and Anthropological research is underway and anticipated to be completed in April 2021. A gender sensitive review of targeted laws and policies governing land and natural resources has been completed. The review will inform a policy statement that will guide the development of the by-laws for Customary Holding Groups under the Customary Lands Record Act. This is currently underway and is anticipated to be completed in January 2021.

Participation of youth and women increased and improved during the TGCFB consultations through the support from the project. Women and youth attended preparatory sessions on the TGCFB prior to the official consultations. The preparatory sessions and the official consultations were organized in a conducive space enabling women and youth to voice their views, make recommendations and actively participate in discussions. Women constituted forty-nine percentage (49%) of those who were engaged and consulted during the workshop. Thirty (30%) were youth (111 males and 77 females).

<u>Outcome 2:</u> Communities adversely affected by land and natural resource mismanagement including VAWG participate more strongly in decisions on land and natural resources.

Rate the current status of the outcome progress: On track

Progress summary: (3000-character limit)

The project is actively working with Ministry of Lands, Survey and Housing and has had a breakthrough with six customary land holding groups in Malaita, Guadalcanal and Western Provinces. This progress has strengthened the synergies between national Government, provincial government and communities. Workshops held for customary landowners has led to increased awareness of legislation and the process of recognising and officially recording customary land.

The incentives to engage women and youth in customary land recording are always challenging. The project has to articulate clearly to the Ministry of Lands, Survey and Housing, Land Recorders and Customary landholding Groups the importance of including women and youth in land recording. The work of the project resulted in 86 women and 31 youth (8 females and 23 males) attending various meetings on customary land in the target communities. The project is not simply aiming for equal participation and inclusiveness in the customary land recording processes, rather the project seeks to understand the key social and institutional barriers to inclusion of women and youth in customary land governance – ownership, uses, policies, practices and institutional.

Three Provincial Youth Councils (PYC) were revitalised in Malaita, Guadalcanal and Western Provinces. Executive members of the PYCs in Honiara, Guadalcanal and Malaita have undergone training in peace building, transparency/accountability, climate change and natural resources governance. Below are some statements made by the Youth during the trainings.

Jason Oihanua- Vice President of the Provincial Youth Council of Malaita;

"I'm very happy because I learnt that to become peace builder is not any easy and is very challenging. To become peace builder in the community, we must have various ways to approach our community people to maintain peace in our communities. Already there are lots of issues with youths and logging in the communities that if not handle in a responsible manner, will result in conflicts and this training is so timely and equip us youth leaders".

Diana Baeta one of the female participants uttered that;

"... so privilege to attend this important training to learn about how to become peace builder. Natural resources cause a lot of conflicts and it's important to equip youths with such skills and knowledge".

Bobby Siarana, President for Honiara Youth Council stated;

"...this training is very rare and first of this kind. It's rare and special as it targets corruption, conflicts and natural resources governance. I have attended workshops, and this is the first training to target corruption and peacebuilding in terms of land, and forestry main causes of conflict and corruption in the country".

The Youth Councils are building their networks and actively engaged in dialogue with donors. In 2021, the project will link these councils to be a part of the advocacy drive to broaden the discourse to inform the drafting of the TGCFB, the inclusion of women and youth as active participants in Land boundary bi-laws, and linking women and youth to private sector initiatives as an alternative to logging.

Most of the target provinces are in the emergency zones which makes it difficult to travel for data collection.

Name of funder: Amount: While no additional funding has been leveraged by the project, the government and non-government partners provided substantive and technical support to the project through in-kind contributions. For example, leading with facilitation of Customary tribal land recording and consultations, information sharing and linking partners from key ministries who were responsible for the land, forestry and environment including climate change, conducting peace building and anti-corruption trainings to marginalized youths, facilitating the consultations on the Traditional Governance and Customs Facilitation Bill (TGCFB). These are critical funding gaps that would not have happened without the establishment of the IGNR project in the Solomon Islands and funding support it rendered towards these activities. The Ministry of Traditional Goverance and Ecclesiastical Affairs (MTGPEA) contributed financially to the initial development of the TGCFB since 2018, until IGNR rendered support to five provinces in 2020. The MTGPEA is funding consultations in the other five provinces that are
	not target by the IGNR project. The Ministry of Land, Housing and Survey (MLHS) supported by providing three of the Ministry's surveyors to assist in demarcation of the customary tribal land. The Customary Land Recording process is a conflict sensitive process. The MLHS has strengthened partnership with the MTGPEA. There is better coordination of national agencies, including creating stronger synergies between the IGNR project outputs and activities.
Other: Are there any other issues concerning project implementation that you want to share, including any capacity needs of the recipient organizations? (1500 character limit)	The main challenge for this year was the delay of implementation due to strict restrictions imposed by the Solomon Islands Government in response to the COVID 19 pandemic. In April 2020, the Governor General declared the State of Emergency (SoE) authorizing the Prime Minister

with the powers to undertake any actions necessary to initially prevent and then to combat a possible outbreak until August 2020. In August 2020, the SoE extended for the next four months until December 2020. Four of the five target provinces were declared as emergency zones and initial curfews were introduced. Despite this, the project continued its engagement with communities in anticipation of restrictions easing out, and ensured essential activities were on track, including the contracting of consultants using vetted rosters or through advertisements, and a UNV who worked remotely.

The Solomon Islands geographical context poses issues and many logistical challenges and high costs for project implementation in terms of travel.
