2. Reason revision is being requested:

Since the approval of the project, the uncertainty of the pandemic along with changes to government plans has delayed implementation of the Joint Project.

Firstly, at the onset of the project, there was a willingness from the Government to create an overarching system for social protection that would harmonize the digital platforms to be created under this project with the existing systems. However, with the dissolution of Ministry of Communications, Science and Technology and the merger of this portfolio in another Ministry's mandate has delayed the process. Discussions are ongoing to expedite the harmonization of the digital platforms.

Secondly, although the government has plans for developing a mobile application for reporting GBV, the government infrastructure to host the digital mechanism is weak. In addition, the physical system for operationalizing the referral mechanism is not in place. Hence, longer time than anticipated has been taken for preparing the Ministries system to be digitalized.

Considering the above challenges, the Joint Program requires an additional 3 months, that is until 1st February 2022 to achieve the results. Hence, requesting for an extension of project duration.
