3. Reason revision is being requested:

All implementing partners of the Haiti Cholera Multi-Partner Trust Fund have faced considerable difficulties implementing their projects due to ongoing socio-political unrest, nationwide protests, and the COVID-19 pandemic. All of these concerns have been exacerbated following the assassination of the President and the multiple changes in government that have ensued.

During this difficult period, the Office of the Special Envoy will continue to operate and provide technical oversight, coordination and guidance to all UN bodies working on the Secretary-General's New Approach to Cholera. Funding for OSE is currently set to expire on 31 of March 2021. Currently, sufficient funding remains to continue operating until July 2022. As such, for the time being, OSE is seeking a no-cost extension to allow it to continue operating until that time.
