### I. PURPOSE

	This project was developed as one of the objectives of the One UN
	Programme 2007-2010 "Building Capacities for Development" in Uruguay.
Programme Description:	The joint project will support and strengthen the capacities for the development of public policies and strategies to address environmental vulnerabilities and sustainability, specifically climate change. The effort will coordinate the "Initiative on Poverty and Environment for Uruguay", "Local Level Climate Change", and "Strengthening of Local Government Capacities for Risk Management in Uruguay".



#### **III. IMPLEMENTATION AND MONITORING ARRANGEMENTS**

To support the One UN Programme, the Government and the UNS in Uruguay agreed to establish the Uruguay One UN Coherence Fund; a common, un-earmarked, development fund, under the leadership of the Resident Coordinator. The Uruguay One UN Coherence Fund supports the coordinated resource mobilization, allocation and disbursement of donor-contributed resources for the unfunded elements of the One UN Programme.

The Uruguay One UN Coherence Fund has several governance mechanisms to ensure proper management of funds, supervision of project execution, and monitoring of results. The mechanisms are: The Coherence Fund Steering Committee, The Coherence Fund Consultative Committee, The Management Committees, and the Administrative Agent (AA).

The members of the Management Committee are: Office of Planning and Budget (OPP), Ministry of Livestock, Agriculture and Fisheries (MGAP), Ministry of Housing, Land Use Planning, and Environment (MVOTMA), National System for Response to Climate Change (SNRCC), the Resident Coordinator's Office (RCO), the executing agencies (UNDP, UNEP, UNESCO) and the associated UN Agencies (FAO, UNIDO, UNIFEM, WHO, UNV).

### **IV. RESULTS**

The Project effectively started on November-2009, and the project Coordinator initiated his activities on December 15<sup>th</sup>.

# Output 1: Strengthen the capacity of the National Response System to Climate Change and local governments reduce environmental vulnerabilities and sustainability while coordinating joint initiatives. (UNDP)

- In the reporting period, the Project progressed with the strengthening of the capacity of the National Response System to Climate Change (SNRCC) and the local governments. The main outcome was the decisive contribution of the Project in the elaboration of the strategic National Action Plan to Climate Change approved by the National Government of Uruguay in December 2009.
- The project elaborated a first draft of the National Action Plan, and developed several activities (a Survey and a communication network) to facilitate the coordination between all agencies involved at the national level and the local governments.

# Output 2: Generate and disseminate information related to the reduction of environmental vulnerabilities and sustainability for their inclusion into public policies being developed. (UNDP-UNEP)

• This output will be initiated in February 2010.

# Output 3: Strengthen the capacity to analyze environmental vulnerabilities and sustainability on the use of water resources as related to climate change. (UNESCO)

• This output will be initiated in January 2010.

#### Output 4:

Project effectively managed, monitored and coordinated with other initiatives, projects, and programmes being implemented, seeking synergies that promote sustainability of the initiative. (UNDP)

• This output began with the contracting of the coordinator the 15 December.

## Difficulties in the implementation, lessons learned to improve management, and knowledge acquired as a result of evaluations and studies carried out throughout the year.

- Although the Project began in late 2009, there are important advances to report in those two first months of operations.
- It is necessary to increase coordination between the UN implementing agencies and the national partners. The first Management Committee organized for 11 February 2010, and it is expected that this Committee will strengthen as a working space and will improve the communication between all agencies involved.
- The difficulties derived from the institutional weakness of the national partner, the SNRCC and the complexity degree of the joint project and the cooperation process (three UN Agencies and a weak national partner that represent a complex intergovernmental network at the national and local level) with an heterogeneity of institutional procedures and Agendas.
- Throughout the National Action Plan process of elaboration, the project has contributed on an incremental interaction between the national and local level governments, which will result in a greater coordination with others initiatives of the United Nations System (UNS) Agencies in the territory.

### V. FUTURE WORK PLAN

- Priority actions planned for the following year to overcome constraints, build on achievements and partnerships, and use the lessons learned during the previous year.
  - During 2010, the Project will strengthen the Management Unit and the coordination between the Agencies and the national partner (SNRCC). The Management Committee will function in a monthly frequency as an actual working space to improve the communication between all agencies involved
  - The joint actions to strengthen local capacities for vulnerability reduction between the programme project initiatives and with others projects will be strengthen by improving the communication mechanisms.
