### I. Purpose

Main objectives and outcomes expected as per approved Project/Programme/project document:

#### The key immediate objectives of the programme/project are to:

To enhance the position of women and youth in the Iraqi political process through:

- 1- Consolidating the role of women in the National Assembly so these women can perform a more effective role, particularly in regard to women's issues and concerns
- 2- Increasing free and open participation of women and youth in the electoral process.
- 3- Strengthening the role of young people in the National Assembly so that the issues of the youth might be highlighted by the youth themselves and thereby encourage more complete participation of this sector of society.
- 4- Assisting the young men and women devise, develop and lead "advocacy strategies", which will place pressure on the political parties and blocs in Iraq that they might increase their number of young men and women candidates in the electoral lists for the National Assembly and also place these candidates higher up in the lists of candidates.

#### The expected outcomes of the project are:

A range of projects have been developed and designed by Cluster G to facilitate the organisation and implementation of the elections such as the provision of logistical support to the IECI. However, while such projects are essential to ensure that electoral process is correctly and properly run, it is also imperative that support is provided to relevant NGO/CSO to ensure that under-represented groups such as women and youth increase their level of participation in future elections. It is with this objective in mind that this project has been designed by the UNEAD/ACHRS supported by the project's executing agency, to assist in the realisation of the Cluster G Electoral Assistance Strategy.

### The expected outputs of the programme/project within this reporting period are:

- 1. Sixty nine partner NGO/CSO are identified as capable of providing the required project support to women and youth groups to enable them improve the involvement and participation in the Iraqi electoral process
- 2. Twenty three representatives (one for each three of the 69 NGO/CSO involved in the project) are trained in public outreach and the preparation of advocacy strategies in 'Training of Trainer' (ToT) courses
- 3. A Guide for the women and youth is drafted, printed and distributed (in 10,000 copies) to help educate them as to how they might be able to participate more effectively in the electoral process and the transitional period in Iraq. In addition, this guide will serve as an 'Awareness Guide' for the general Iraqi public while also focusing on those issues most pertinent to women and young people.
- 4. Up to 6210 women and youth participants are trained in 207 Awareness sessions/workshops organised by the NGO/CSO in order to inform them of the relevant major issues and to encourage their participation to as great an extent as possible in the electoral process
- 5. A publicity campaign using multi- media strategies promotes the concept of women and youth involvement in future electoral processes inside Iraq.

<u>UNOPS</u>: The executing agency UNOPS will be supported by UNEAD through provision of technical supervision. Management and oversight of the project will be according to standard UN procedures laid out in the programming manuals of UNOPS and the reporting requirements agreed between UNEAD and Cluster G.

**<u>UNEAD</u>**: Supervising Agency. UNEAD will be providing technical supervision.

<u>ACHRS</u>: The ACHRS will carry out activities based on a Letter of Agreement which has been signed between ACHRS, UNEAD and UNOPS. ACHRS will conduct all training courses outside of the country in cooperation with UNOPS/EAD. ACHRS will also supervise the overall progress of work on the project through a full-time team which will be based in various locations in Iraq for all the incountry activities. The project implementation strategy will be continuously reviewed by the ACHRS and where it proves necessary corrective action will be taken. ACHRS will sign an MOU with each selected organization to specify the use of the funds received, equipment received and public outreach funds. UNOPS and UNEAD will review the single MOU documents prior to signature by ACHRS. The MOUs will also require the recipient of the funds to provide reporting on activities and expenditure.

#### Main activities undertaken and achievements/ impacts:

- Selection of 69 NGO/SCO
- ACHRS signed MOAs with the selected organisation regarding the use of funds received.
- Training Courses "Training of trainers" was delivered for the appropriate trainees selected by partner NGOs.
- Transfer of workshops support funds from UNOPS to ACHRS and further to the 69 NGOS/SCOs to support the cost of the workshops.
- Drafting, printing and distribution of an advisory guide "awareness guide" to women and youth in Iraq.
- Organising and holding 207 awareness sessions for the public. In total, each of the 69 NGO/CSO delivered 3 workshops at different locations throughout Iraq making a total of 207 in all. The awareness guide produced by the project was distributed to all the participants in these workshops.
- Giving a media focus on women issues in Iraq, a public outreach campaign was delivered to promote the role of women and youth in future Iraqi elections.

Implementation constraints, lessons learned from addressing these and knowledge gained from assessments, evaluations and studies that have taken place during the project:

The main challenge of security situation and the limited ability of movement of people in Iraq is the greatest obstacle towards smooth implementation.

#### Key partnerships and inter-agency collaboration, impact on results:

UNOPS is collaborating with ACHRS and UNEAD for the successful implementation of this project

# Highlights and cross cutting issues pertinent to the results e.g. gender disaggregation, policy engagement and participation of the public:

**Security:** The security situation in Baghdad did not allow ACHRS to conduct one of the initial seminars planned for the center (Baghdad). Three attempts to hold this session ended by cancellation, therefore it was decided to adopt the outcome of the other two initial sessions of (North and South) provided that a third session to be held in Baghdad immediately when the security assessment allows for such an activity to take place.

**Gender:** As this project is specifically designed to promote the increased involvement of women and young people, it will benefit both women and men. Furthermore, the project deals extensively with gender issues in addition to improving the political status of under-represented sectors of the Iraqi population.

The project's outreach campaign ensured that also (older) men are addressed and thus included in the awareness raising (e.g. re women's access to the political process).

**Human Rights:** This project has human rights as a central component of the project through its objective of ensuring that women and youth are able to participate fully in the evolving political situation in Iraq.

**Employment:** This project does not have a direct long-term impact on employment. There is a number of short-term positions, which are available during the project's actual implementation phase.

By providing support to the selected NGO/CSO the project will enable these bodies to improve their delivery of support to women and youth and to increase their participation in the electoral process. In consequence, these organisations will be in a better position to access funds from donors for future programmes.

It is anticipated that the more successfully future Iraqi electoral processes are conducted and the greater the acceptance of their outcome is as a result, the greater the possibility there will be for Iraq to develop and for all its citizens to benefit from the increased employment opportunities that will surely arise consequently.
