

**MEMORANDUM OF UNDERSTANDING  
BETWEEN  
THE INTERNATIONAL ORGANIZATION FOR MIGRATION (IOM)  
AND  
THE UNITED NATIONS DEVELOPMENT PROGRAMME (UNDP)  
REGARDING THE OPERATIONAL ASPECTS OF THE DRC STABILIZATION  
COHERENCE FUND (SCF)**

This Memorandum of Understanding (hereinafter referred to as "Memorandum") is concluded between the International Organization for Migration (IOM), an intergovernmental organization, established by treaty and having its headquarters at 17, Route des Morillons CH-1211 Geneva 19, Switzerland and United Nations Development Programme, a subsidiary organ of the United Nations, having its Headquarters at One United Nations Plaza, New York New York as Administrative Agent of the Congo Stabilization Coherence Fund, (hereinafter "UNDP").

**WHEREAS**, the Participating UN Organizations to the SCF have signed a Memorandum of Understanding relating to the Operational Aspects of the Fund (attached hereto as **Annex I**).

**WHEREAS**, IOM wishes to participate in the SCF and receive funds on the same terms as the Participating UN Organizations.

**WHEREAS**, the Participating UN Organizations and the Donors to the SCF agree to IOM's participation in the SCF.

**WHEREAS**, The Participating UN Organizations authorize UNDP as Administrative Agent to conclude this Memorandum with IOM for its participation in the SCF.

**NOW, THEREFORE**, IOM and UNDP hereby agree as follows:

1. IOM warrants and confirms that it has entered into relevant basic agreements with the Government of the Democratic Republic of Congo, as a basis for its activities.
2. IOM warrants and confirms that it has privileges and immunities in respect of its personnel and assets consistent with those of the Participating UN Organizations in the Democratic Republic of Congo, including functional immunity of its personnel and assets, and immunity from legal process and from search and seizure.
3. IOM agrees to carry out its activities on the terms and conditions of the Memorandum of Understanding entered into between the Participating UN Organizations and the UNDP attached hereto as Annex I, which is an integral part of this Memorandum.
4. For Notices under this Memorandum, the addresses of IOM and UNDP are as specified in Annex II hereto.
5. This Memorandum of Understanding will come into effect upon signature by authorized officials of the Participants and will continue in full force and effect until it is expired or terminated.
