

PART 1: OVERALL PROJECT PROGRESS

Briefly outline the **status of the project** in terms of implementation cycle, including whether preliminary/preparatory activities have been completed (i.e. contracting of partners, staff recruitment, etc.) (1500 character limit):

The project is on track. Although the global COVID-19 pandemic has initially severely affected the project implementation since early March, adaptive measures, such as digitization of capacity-building components, continue to be put in place to respond to the new operational circumstances. In April, the project received a 9-month no-cost extension, allowing additional time to implement all planned activities also in response to the impact of COVID-19 on project activities. As a risk mitigating measure, all contracts and grant agreements were revised and adapted to include digitization components, where possible, or prolonged implementation period. The Joint Annual Workplan for 2020 was adapted to include revised milestones. Due to the operational circumstances, the Joint Programme Board meeting, was adapted to an electronic session in June. The Call for Proposals was launched in December 2019, following the validation of joint social cohesion priorities and actions at a Regional Dialogue Platform. Their priorities contributed to the themes of the cross-border Small Grants Facility, providing for selection of 19 projects in support of youth empowerment, improved inter-cultural cooperation and understanding, strengthened dialogue, gender equality, non-formal education, environmental protection. The Social Media Communications Strategy was drafted and agreed, with a view to engage Millennials and Z Generation on promotion of shared values and messages, as well as work to suppress stereotypes and deep-rooted biases that young people in the three countries have for each other, within respective countries or among.

Following the completion of evaluation in all three countries, and as part of activities under Output 2.4, the program will award 19 <u>cross-border grants</u> during June, supporting partnerships among CSOs, public institutions and schools in the three countries to advance youth capacity-building, intercultural understanding and dialogue, empowerment of visually-impaired women, safeguarding of the environment as a common good and advocating for the rights of marginalized groups. Additionally, furthering support to joint action on identified priorities under Output 2.4, the social entrepreneurship platform, <u>UPSHIFT</u>, will continue in digital format as of July, allowing for national iterations of this program for adolescents and youth to proceed unimpeded. In support of thematic regional dialogues planned under Output 2.5, the <u>Regional Youth Dialogue</u> is tentatively planned for the Fall or Winter of 2020, with due care to any outstanding risks posed by the COVID-19 pandemic, bringing together close to 100 adolescents and youth from three countries to share examples of their leadership and identify specific cross-border priorities they can address together.

In Montenegro, two youth from northern and southern parts of the country (young man, 19 and young woman, 26), were inspired by their participation in the youth and national dialogues within the program, and continued to be engaged in social cohesion and peacebuilding initiatives in the region by joining the Youth Consultative Group, established within the PBF-funded UNDP/RYCO Albania project, to co-design the youth perception survey that will be launched later in 2020. Nabi and Hadi are two uprooted boys, living in the refugee camp near border in Serbia. Together with Nina, girl from the majority population they have created a team. All of them are 16 years old and their team "Just Human", is one of the many participating in the UPSHIFT programme in the Republic of Serbia. They organized two events to bring together refugees and the local population. "I think that if teenagers and others spent more time together, they could get to know each other better and that can change their minds. That can help to beat discrimination in Sid.", believes Nabi. <u>Outcome 1:</u> Stability and trust in the region, and especially in Bosnia and Herzegovina, are enhanced.

Rate the current status of the outcome progress: on track

Progress summary: (3000 character limit)In Bosnia and Herzegovina, the youth capacity-building component has been adapted to online format, with the last module on crowdfunding and project design delivered via digital platform for 25 youth across the country. All workshops will be recorded, lending it for future use and making the learning material available to other participants. As part of the COVID-19 adaptation process, UPSHIFT social entrepreneurship platform has been digitized, with the first iteration for BiH adolescents and youth to commence in July 2020. During the reporting period, in collaboration with the Faculty of Political Sciences, work has been laid to introduce 'society, religion and culture in digital age' as part of curricula of the Sarajevo Canton Ministry of Education, focusing on soft skills, interculturalism and social cohesion. Additionally, partnership with Faculties of Political Sciences in Sarajevo, Belgrade and Podgorica was established aiming to promote sustainable regional partnership on Media and Information Literacy (MIL) and introduce core elements of this model into training curriculum for primary and secondary schools' teachers. The component of women's capacity building focused on gender equality and women's rights in BiH context, social justice, state of social cohesion in BiH, communication, building trust and respect for diversity, public policy-making processes in BiH context, leadership, advocacy of priorities, forms of citizen participation was completed in February 2020, with 84 women from 28 municipalities across the country, drawn from civil society and public sector, completing a series of learning seminars on leadership, advocacy, public policy and self-representation.

In **Montenegro**, the regional dialogue for women took place in February. Eighty-eight participants (84 women and 4 men from Montenegro, BiH and Republic of Serbia) discussed social cohesion and gender equality, contributing with inspiring examples of community action and leadership across the public and private sector. The meeting identified a series of priorities, but also pointed to possible actions that could be supported through the program. The programme team is working on country level as well as regionally to identify conclusions which can be taken further for policy action and/or implementation.

A group of 24 young diplomats and public servants in charge of international cooperation and EU integration participated in the first module of social cohesion and intercultural communication training. The training programme has been implemented in close partnership with Ministry of Foreign Affairs of Montenegro and consists of this face-to-face training, to be followed up by webinars and online learning and discussions. The participants were selected based on the call that was distributed across the institutions. The activity is aiming for building capacities of young diplomats and civil servants active in regional and international relations to better understand and contribute professionally to social cohesion, dialogue and intercultural communication. Their feedback was very positive, and they have shown eagerness to explore

notions of interculturalism and social cohesion, having in mind both their importance and lack of opportunities to learn and discuss those.

The first regional UPSHIFT for youth from three countries took place on 5-8 March. Applicants from all three countries were organized into 10 mixed teams, out of which five were awarded grants to work on their team projects. The Covid-19 pandemic has stalled implementation of these projects; however, they are being restored with ease in movement restrictions across communities. As part of the capacity-building component, the second cohort of 31 women from CSO, media and public sectors learnt about gender equality, social cohesion, advocacy and community action.

In the **Republic of Serbia**, the second hackathon for young developers, designers and activists from the three countries, which took place in December 2019, was unique opportunity to develop concrete ideas for projects that might be implemented in the future, depending of the funding availability. Project ideas were prevention of peer violence and boosting of volunteering opportunities by building of volunteer online platform for participants from 3 countries. Capacity-building seminars for women continued, with 36 selected young women from Serbia learning about the importance of active engagement. Participants who attended two educational seminars were equipped with knowledge and skills to act as agents of change in their local communities. They will continue to be part of a network, relied upon also by other projects. During the reporting period, data on the perceptions of youth in Serbia regarding volunteerism, violence towards children and digital skills enhancement were collected using uReport, for the purpose of changing strategic and legal framework for above mentioned topics. Work continued with the Ministry of Education and Technological Development on the educational reform of the civic education (CE) curriculum and teachers' practices. Through this engagement, teachers are continually supported in developing key competences for teaching reformed CE curriculum. Through the UPSHIFT social entrepreneurship platform, five teams are implementing their community projects on combating discrimination, enhancing school accessibility, creating supportive environment for increasing literacy skills, cooperation between young people etc.

The program has a dedicated component to youth and women's leadership respectively, while gender equality is a principle that is applied across all components of the program. Additionally, the principle of gender equality was embedded in grant application forms, seeking to ensure a balanced approach in interactions and work with final beneficiaries. Gender equality, women's empowerment and youth inclusion were among the seven priority themes of the cross-border Call for Proposals. Of the 19 selected cross-border projects, 4 are either directly focused on GEWE or implemented by women's organizations, while 5 center on youth advocacy and leadership. In terms of institutional partnerships, it is of note that the Montenegrin Ministry of Sports and Youth included 7 recommendations from national dialogue events into their baseline document defining future grants schemes in 2021. Social cohesion analysis was also inserted in the document. This testifies to impactful synergy and policy leverage the program has achieved to date.

(1500 character limit)	Recognizing the complexity of joint multi-country and multi-agency projects, UNDP BiH developed the SOP document in the project design phase, which was broadly consulted among teams and remains a living document to ensure coherence and consistency for joint project's operations. The forthcoming elections schedule (June in Serbia and plans for the Fall in Bosnia and Herzegovina, and possibly Montenegro) may have an impact on the continuity of relationships the program has established, due to possible re-appointments of officials in line with election results, generating changes in the composition of the Joint Program Board. Most significantly, this may affect the achievement of Output 3 (policy recommendations and advocacy). The program faced a challenge with the methodology and implementation of the baseline perception survey, looking
	into possible synergies with the methodology chosen under the national joint DFF project, while at the same time adapting to the requirements of a multi-country format. Ultimately, to address this methodological challenge and ensure rigor, the Service Provider proposed that end-line measurements of all target group samples would be compared against control group samples in each country, while a baseline/end-line approach would be implemented for the beneficiaries of cross-border small grants, thereby increasing the overall survey sample and gaining insight into the changes of perceptions for the final beneficiaries of the
	joint program.
