It will include an exhibition narrating the history of the conflict and the story of the peace, a memorial to honor the suffering of the conflict's victims, and an archive that will include war-related materials, such as the Special Court's public records and those of the Truth and Reconciliation Commission. The content and management arrangements for the Museum will be designed by a committee of national stakeholders.

Establishing the Museum	The Museum has been physically separated from the security room which occupies the same building and separate access provided to both. Construction work is ongoing to modify the internal space. The Project Management Team (PMT) has created a draft Articles of Association to establish the Museum as a legal entity.	Of various designs considered for the Museum, the PMT was not able to choose more ambitious options given the limitations of the budget.
An exhibition that narrates the history of the war	Drafting a narrative for the exhibition and the collection of exhibits are ongoing. The PMT has drafted a collection management strategy to guide exhibit collection and management. Publicity to call for donations of exhibits is underway.	The network of partners that will collect exhibits around the country has not been set up yet and no external expert has been located to assist in designing the exhibition. This may delay the completion of the Museum.
A memorial to honour the suffering of the war's victims	The memorial design competition began on 1 August and is seeking designs for the memorial from the public. The deadline for submissions is 31 October.	
A library with war-related materials	The Special Court records are being prepared and planning for organizing the Truth and Reconciliation Commission records will allow work to begin in the next quarter.	
A training facility that gives the justice sector access to the Court's training materials	As noted above, construction work is ongoing to provide such facilities in the building.
