Output 1: Increased institutional capacity of IHEC to independently carry out elections.	The required international electoral advisors were in place during the reporting period to provide assistance to the IHEC in its preparations for future elections. Five international consultants, recruited in previous quarters, worked closely with the IHEC and UNAMI to ensure the proper planning, coordination and execution of activities in support of future elections. Recruitment was initiated for one additional short-term consultant.	% of planned 88 %		

Qualitative achievements against objectives and results

During the reporting period, the following international experts were in place, to provide technical advice, operational support and capacity development to the IHEC in Baghdad.

- 1. Procurement and Logistics Advisor (initial 6 month contract from March 2011 extended until April 2012)
- 2. Electoral Complaints Advisor (7.5 month contract closed mid November 2011)
- 3. Coordination Advisor (11 month contract closed end November 2011).

The Coordination Advisor continued to support the implementation of the 2011 technical assistance plan for the IHEC, and to ensure appropriate coordination takes place in the implementation of this plan, both with the IHEC and also between UN and other partners.

The Procurement and Logistics Advisor worked closely with the IHEC to ensure the proper planning and execution of procurement and logistics activities, and to work towards ensuring preparedness of the IHEC in electoral and public procurement for future electoral events.

The Electoral Complaints Advisor continued activities with the IHEC to improve IHEC electoral complaints processes, and completed a review with the IHEC of relevant components of the electoral legal framework for potential elections in Iraq.

This represents on-going technical assistance to the IHEC by securing international electoral experts to provide the necessary technical advice and operational guidance to the IHEC for electoral activities. All project activities were undertaken for all international expert advisors. All advisors have assisted in providing both operational technical support to preparation of electoral events, and in capacity development through ongoing guidance to IHEC staff. UNDP specific contribution to this overall goal is the timely mobilization of technical expertise to support the IHEC.

Main implementation constraints and challenges

The security factor remains the main obstacle to the deployment of additional staff in Iraq. However, the staff ceiling has been slightly raised to accommodate additional UN personnel to support the electoral process. For the same reason of security some international electoral experts (who are limited in number) are reluctant to take positions in Iraq; nevertheless, UNDP continues to seek qualified personnel and identify them for recruitment.

An important aspect of the UN's electoral support is the close relationship with the IHEC and daily presence in Baghdad, working directly with IHEC counterparts. From January-August 2011, access of UN personnel to the IHEC National Office was limited, thus reducing face-to face time with IHEC counterparts. This, however, improved in September 2011, with new measures in place to increase UN access to the IHEC facilities and regular access was facilitated for UN advisors to the IHEC for most of the reporting period.
