### ç.s **Reason Revision is being requested**

approximately USD 102,950 is still available and is enough to purchase additional cartons of RUTF. UNICEF anticipates that procurement, transport and distribution of these additional cartons will take approximately 4 months from the middle of October 2012. Therefore, UNICEF intended to purchase 14,250 cartons of Ready to Use Therapeutic Food (RUTF) at the actual cost per carton was significantly less than planned at USD 46. As such, a unit cost of USD 55 per carton. To date, UNICEF has purchased 14,800 cartons. the number of cartons and final beneficiary numbers are approximate and could well be higher, especially as 14,800 cartons have already been purchased at USD 46. beneficiaries, as it is difficult to accurately predict what the exact unit cost will be, and in turn has been amended to reflect an average unit cost of USD 50, and a total number of 15,675 (current expiry date of the CHF grant) to 30 April, 2013.
