Thailand, 10-14 September 2012 adopted conclusion C 23/51, that States/Administrations should:

(a) develop, update and test aviation public health emergency (PHE) preparedness plans in collaboration with public health authorities, in compliance with related ICAO Standards and Recommended Practices (SARPs) and WHO IHR (2005), and prepare for the ICAO Universal Safety Oversight Audit Protocol (USOAP) Continuous Monitoring Approach (CMA) audit which, from 2013, will include protocol questions concerning PHE related ICAO SARPS; and,

(b) consider become participating members of the ICAO CAPSCA Asia Pacific (APAC) project, if not yet members, and accept PHE Preparedness Assistance Visits by the ICAO CAPSCA Asia Pacific Project, by sending a letter to the ICAO APAC Regional Office.

Qualitative achievements against outcomes and results:

- Cooperation between the Aviation Sector and Public Health Authorities continues to be developed.
- Compliance by States with ICAO Standards and WHO IHR (2005) and associated guidelines continues to be enhanced.
- Airports Council International are developing guidelines for Business Continuity Planning.
- Continued efforts to promote participation of APAC States in CAPSCA-AP project.
- Continued efforts to motivate APAC States to accept Assistance Visits by the ICAO CAPSCA AP Project.
