**ACTIVITIES REPORTED:** 

**Main Substantive Activities:** 

Knowledge management system and user manual completed. Baseline information is available and disseminated on policy and legislative framework for integrating environment in cultural heritage. Needs and capacity assessment completed in 9 regions with key recommendations for community based actions in handicraft development. The National Heritage Act, 2004 (Act No. 27 of 2004) review completed with focus on integrating Intangible Cultural Heritage (ICH). Town and Regional Planning Act reviewed and key national stakeholders engaged in strategic planning for Namibian Urban Policy. The JP initiated the implementation of the UNESCO Convention 1972 in Namibia through professional training on the Preparation of Nomination Dossiers.

A strategic plan was developed for the implementation of the 2003 UNESCO Convention on the safeguarding of ICH in Namibia and actual inventories of ICH elements conducted by local communities following two training workshops on the documentation methods. Heritage Management Plans were developed focusing on conservation, management, HIV and AIDS impact, as well as marketing for the sites that were proclaimed as National Heritage Sites. Territorial diagnosis and institutional mappings were completed for each of the 9 pilot sites. A Heritage Handbook was developed and translated into different local languages. A supply and demand analysis was commissioned. Training Manuals were developed and used for training of local beneficiaries on the concept of Start Your Own Cultural Business (SYCB).

#### Problems and lessons learned:

**Managerial:** Extensive capacity building required for local partners.

**Joint Programme design:** More detailed preliminary assessment and community involvement required as well as careful and focused involvement of partnering groups in targeted local communities.


