ACTIVITIES REPORTED:

Main Substantive Activities:

Enhanced coordination between subnational governments to carry out environmental functions established in the National Environmental Management System. Regional governments of Cusco and Apurimac have climate change adaptation strategies and related implementation plans. Diploma program on climate change management has graduated 45 participants. Provincial governments of Chumbivilcas and Cotabambas and local municipalities members of AMSAT have climate change adaptation plans, environmental management offices and Municipal Environmental Commissions. Specialized equipment (meteorology and geographic information systems) are installed in both provinces. 9 pilot communities have climate change adaptation strategies and appropriate irrigation systems. 4,000 communities members are trained on water use and water and waste management, breeding, reforestation, adaptation techniques, among others, and 86 farmer field schools are implemented (with more than 1,300 participants). Radio programs in Quechua and Spanish are available to promote climate change adaptation in 9 pilot communities. 509 households in pilot communities with healthy style of living ("improved" kitchens). Pilot communities adopting flexible production models; examples of uses of seed money provided by the JP include infrastructure for "cuy" farming, planting of 20,000 trees, and greenhouse improvement.

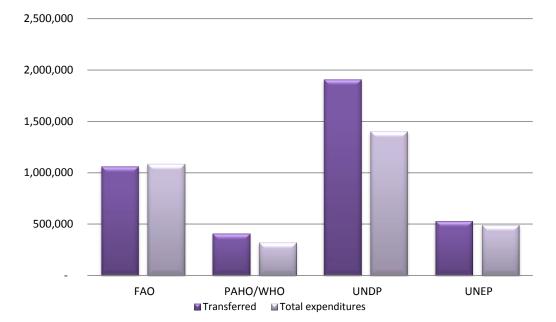
