# Qualitative achievements against expected results<sup>5</sup>:

To date, progress is as follows:

- Structural and functional analyses of buildings potentially useful as evacuation shelters in the PaP metropolitan area (with MTPTC, Ministry of Affairs Sociales, DPC, World Bank); 500+ buildings evaluated
- Creation of guide to evacuations with DPC, MAST, DINEPA, World Bank, USAID/OFDA, Haitian Red Cross and others:
- Day-long workshop with DPC, mayors of the PaP metropolitan area, MAST, DINEPA, World Bank, USAID/OFDA, Haitian Red Cross on the question of evacuations, including shelter management, identification of sites and coordination at the local level;
- Update of 2009 DPC inventory of buildings identified as evacuation shelters (all ten departments) over 600 buildings visited and evaluated for functional purposes (non-structural).
- Construction and rehabilitation of evacuation shelters;
- Creation of 60 Disaster Risk Management committees in camps and at-risk committees;
- Local level early warning systems in camps with DRM committees;
- Training in basic first aid and large community first aid kit distribution in over 60 IDP camps (more than 300 people total) and vulnerable surrounding communities;
- Sensitization on cholera risks related to rainy season;
- Workshop for Departmental Technical Coordinators on evacuation planning to present the Guide on evacuation shelter management and begin planning for the 2012 cyclone season.

#### Challenges and other comments

### What challenges are currently facing your project?

The primary problems faced by the project were issues over land title and the lack of availability of land. IOM, understanding the complexity of land and property issues in Haiti, puts great emphasis on the clearing of title and is often able to accelerate the process through its land and property specialists. However in certain cases (for example Gonaives) delays in clearing title and ensuring appropriate signatures, etc. delayed some construction and in a few cases has forced IOM to intervene elsewhere.
