- In December 2013, PBF Joint Steering Committee in Guatemala agreed to reallocate the funds of the Priority Plan-Result 6 (USD 270,000.00), to Result 2 in order to support the request made by the UN International Commission Against impunity-CICIG to boost an important project on the creation of a new criminal investigation police body (Policia de Investigación Criminal –DIGICRI-) (USD 170,000.00), and to strength the output related to Monitoring & Evaluation to consolidate the PBF M&E mechanisms and to strength the functions of the PBF Secretariat (USD 100,000.00). This reallocation will be managed through an amendment of the Project PBF-GTM-B1 Strengthening National Capacities for the Criminal Investigation/80403, which ended on February 2014.
- Therefore, this no-cost extension is requested to extend the project PBF-GTM-B1 Strengthening National Capacities for the Criminal Investigation/80403, until 15 May 2014 to allow the preparation of the Project amendment that incorporates the outcomes before mentioned.
