Project Summary	The project will improve access to emergency water supply, sanitation and hygiene services for conflict affected and vulnerable host communities. The project will provide WASH services for IDPs and vulnerable host communities with permanent and semi-permanent WASH facilities and improving hygiene practices. The project will also prioritize reestablishing WASH facilities in IDP returnee locations and strategic urban areas in conflict affected areas and improve WASH services in areas with high risk of WASH related disease outbreak. The project will reach a total of 55,750 people. From these 26,500 people will be reached by sustainable safe water supply, 29,250 people will be reached by sanitation facilities. Hygiene promotion activities will be reaching the whole 55,750 people targeted by water and sanitation interventions.

Link with the Allocation Strategy	<p>The project designed within the framework of the three cluster objectives for emergency affected populations and vulnerable communities, and it is contributing directly to all the three objectives.</p> <p>Safe water supply intervention through rehabilitation and construction of water facilities, water trucking and RRM missions are all targeting emergency affected populations in IDP camps, hard to reach locations and vulnerable host communities. The sanitation component is also targeting same population with emergency and semi-permanent sanitation facilities.</p> <p>Hygiene promotion component contributing to Cluster objective 3 and focusing on prevention of cholera and other water born disease in the areas affected by recent cholera, cholera endemic areas, IDP camps and large displaced people settlements.</p> <p>The project will be focusing on construction, rehabilitation and reestablishment of WASH facilities for IDPs and communities at very high risk of diseases outbreaks and high rates of malnutrition by using the opportunity of the dry season from January to June to ensure more sustainable and long term facilities are provided for the above vulnerable communities to minimize the risk of an outbreak and save lives of people at greater risk due to the conflict and high disease burden. BACKGROUND INFORMATION

1. Humanitarian context

analysis.. Humanitarian context: Describe the current humanitarian situation in the specific locations where this project will be implemented

The ongoing conflict has a negative impact on WASH services, with over 40 per cent of WASH facilities in the three most affected states destroyed. South Sudan had low access to safe water and sanitation, at 41 per cent and 14 per cent respectively before the conflict. Poor maintenance, and over 1.4 million IDPs competing for the limited facilities has increased pressure on the existing facilities in the host communities. Despite the on-going efforts by humanitarian actors to address the needs, the continuing emergencies leave the populations exposed to the risk of waterborne diseases and deny them livelihood opportunities. Women and girls are exposed to gender based violence affecting their health. The inadequacy of WASH facilities in child friendly spaces discourages girls and boys from using the facilities due to sexual violence in the limited facilities.

The situation of the displaced population is dire with overcrowding and limited facilities. Acute Watery Diarrhoea is the third leading cause of child mortality in the camps at 34 per cent of the disease burden. Children with malnutrition are particularly susceptible to diarrheal diseases which require a combined and integrated response with health and nutrition sectors.

The ongoing humanitarian crisis in South Sudan has been further complicated by an outbreak of cholera, which was declared by the Ministry of Health on 15 May 2014. As of 23 November 2014, the cumulative number of cholera cases reported is over 6,421 with 167 deaths to a Case Fatality Rate of 2.6 per cent, much higher than the accepted emergency threshold of 1 per cent. In order to contain the spread of cholera to new locations, WASH actors will enhance efforts to improve the water, sanitation and hygiene situation in endemic areas and highly vulnerable communities. Therefore the continued insecurity, disease outbreaks and other natural emergencies like flood combined with poor infrastructure throughout the country highlights the need for UNICEF and its partners to continue providing emergency services to these vulnerable populations in 2015.

WASH Sector partners conducted a number of Assessments in different locations affected by the conflict and identified critical needs on WASH services and rehabilitation and upgrading of WASH facilities for IDPs. In communities hosting large number of IDPs large number of WASH facilities are either non-functional or over utilized to cope with the increased pressure in the target locations. In addition sanitation facilities in most of IDP locations are not yet reached the SPHERE standards and continuous replacement and improvement of sanitation facilities are required. Therefore this project will focus on improving water supply and sanitation services in conflict affected states of Jongeli, Upper Nile, Unity and Lakes and sustaining the WASH survives of solid and liquid waste disposal ongoing by UNICEF in Malakal POC.

3. Description Of Beneficiaries	The targeted beneficiaries under this project are about 250,000 vulnerable people. Over 60% of the targeted beneficiaries are women and children and about 50% are children under age of 18. The majority of the population targeted by the project are displaced by the current conflict across Jonglei, Upper Nile, Unity and Lakes states whom it was difficult to reach during the rainy season with WASH services due to poor road infrastructure, flooding and insecurity. The project will also help to re-establish WASH facilities in the urban areas of the affected states where populations are returning to original settlements to facilitate smooth return and resettlement where security situation allows. In addition, the project will also reach high disease prevalent areas in Eastern and Central Equatorial states with WASH services and hygiene promotion. The target beneficiaries are identified based on the population in need as indicated by Humanitarian Needs Overview of South Sudan as approved by HCT in October 2014. UNICEF project beneficiaries are targeted based on the level of vulnerability, presence of other humanitarian partners and UNICEF presence and strategic advantage to deliver results in more efficient and effective way.
4. Grant Request Justification.	This project will mainly undertake frontline emergency WASH service delivery to displaced populations and others in need by engaging the private sector and direct UNICEF implementation together with government counterparts and local NGOs and CBOs. UNICEF has been the lead agency for provision of emergency WASH services including drilling of boreholes, rehabilitation/upgrading of water points in critical IDP locations like Bentiu, Bor and Minkaman and established long term agreements with different contractors for drilling and upgrading works including construction of semi-permanent sanitation facilities which will help the implementation of this project within the indicated timeframe. UNICEF has been working with a number of NGO and CBO partners in areas highly affected by the conflict to ensure provision of basic WASH services, and minimize the suffering of the displaced populations and vulnerable host communities. Additionally, the project will support expansion of existing partnerships with NGOs and CBOs operating in hard to reach locations and have a very limited or no access to funding from international donors. UNICEF has also been the lead on development and production of hygiene promotion materials for cholera and other WASH related diseases and training of government and NGO partners on hygiene promotion and social mobilization, which put it a better position to coordinate and lead the development of communication materials and hygiene promotion for prevention of cholera and other water related diseases in targeted locations by this project.
5. Complementarity. Explain how the project will complement previous or ongoing projects/activities implemented by your organization.	The project will complement ongoing water and sanitation improvement being implemented by UNICEF and other cluster partners in different conflict affected locations and to ensure SPHERE standards are met in POCs and other IDP locations. The water supply intervention will also reach host communities in affected areas host large number of IDPs and existing water supply systems are overstretched with increased beneficiaries.

UNICEF WASH section has a field presence in all States of South Sudan and the WASH officers and specialists in each state and location will be participated on the planning, implementation monitoring and reporting of WASH interventions. Staff based in the field providing on-going monitoring of activities through regular interactions with implementing partners, contractors and local Government counterparts where possible and reporting to UNICEF Juba office on biweekly basis. UNICEF Juba will be responsible for compiling and reporting on progress and final achievements to CHF and to ensure efficient utilisation of resources as well as accountability, transparency and integrity of staff and implementing partners. This also includes joint monitoring by Government, UNICEF and other partners to project sites. In addition to field level monitoring the WASH team in Juba will provide direction and guidance for timely, effective and coordinated implementation of the project activities. The implementing partner will be reporting to UNICEF on narrative progress on monthly basis and financial utilization on quarterly basis which will show the progress, challenges and constraints and help timely adjustment of the project as required.

The UNICEF WASH Officers/Specialists in the field provide regularly monitor the implementation of the programme through regular field visits and supervision of project activities by contractors and NGO partners and send biweekly progress report on the implementation of the project activities in their respective areas to UNICEF WASH Section in Juba. In addition UNICEF will be submitting final narrative and financial report for CHF Technical secretariat as per CHF guidelines and provide progress reports as required by HC for management purposes.

OTHER INFORMATION

Accountability to Affected Populations To integrate accountability for the beneficiaries the UNICEF WASH programme closely work with communities from project initiation, implementation and monitoring of results. UNICEF and its implementing partners will ensure that active community consultations are conducted on designing of the facilities, selection of locations for WASH structures and establishing of management structures. Regular field and onsite monitoring and coaching will be provided and UNICEF will also undertake internal and external reviews of its performance. Financial accountability will be delivered in line with UN HACT Assurance systems. During the implementation, the project will engage beneficiaries in project implementation.

Implementation Plan: Describe for each activity how you plan to implement it and who is carrying out what.

The project will be implemented by direct implementation of UNICEF by engaging private sector contractors with a very close implementation monitoring by UNICEF WASH Staff who are based in all the target states. The water supply construction and rehabilitation components will be implemented by using IAS- International Aid services which has a very good reputation on drilling and construction of water supply points with a lower price than contracted works and have an internal capacity for drilling and rehabilitation works both with regard to equipment and human resources. IAS also willing to access the project target areas in Jongeli and Upper Nile states which is very difficult for many private sector contractors. IAS will be providing detailed work plan at the beginning of the project for the activities planned in partnership with the organization and UNICEF field staff will follow up on the implementation accordingly and provide feedback and suggestions for any adjustment required on the implementation timeframe and quality assurance.
